Fraternal Greetings from Lodge Hyderabad No. 50

We have been missing your presence at our meetings for quite some time; please try to attend at least once in a while. Meanwhile, I wish to draw your attention to the fact that, despite numerous calls, E-mails/WhatsApp messages, your dues to the Lodge (*comprising the annual subscription + the statutory dues to GLI & RGLSI*) amounting to Rs.17,100/- remain unpaid for well over a year.

We are constrained to send this notice to you because, under Rule 124 of the Book of Constitutions, if the subscription dues remain unpaid for one full year, you will come under automatic cessation whereby you will cease to be a member of all Lodges under the GLI. (*The Rule is reproduced below for your reference*).

You are kindly requested to pay the subscription dues within 30 days from the date of receipt of this letter as we do not wish to lose you as a member under Rule 124 of the Book of Constitutions. Therefore, please write a cheque for Rs.17,100/- drawn in favour of "Lodge Hyderabad No. 50" and post it to the Treasurer's address mentioned below.



## Rule 124:

*"Should the subscription of a member of any Lodge remain unpaid for one full year, at the expiration of the period, he shall cease to be a member of all Lodges, provided such a member has been duly served with a notice by Registered post with acknowledgement-due of being in arrears of the subscription amount and the member fails to make payment within 30 days of receipt of the notice. The fact of cessation shall be reported to the Lodge at the next regular meeting and recorded in the minutes and shall be forthwith notified to the Grand Secretary."*
