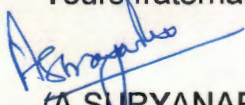

Existing By-Laws	Amended By-Laws
By-Law No. <u>1</u> A person who is a member of ICAI or Institute of Company Secretaries of India or the Institute of Cost and Works Accountants of India, is eligible to be a member of this Lodge; However this restriction will not be applicable in the case of a tyler who shall be a Master Mason and a subscribing member of any Lodge in India.	By-Law No. <u>52 to 521</u> <u>1</u> A person who is a member of ICAI or the Institute of Company Secretaries of India or the Institute of Cost and Works Accountants of India or members in the profession of Business Management with a professional degree or in the profession of all faculties in Engineering and Science or in the Medical Profession with a professional degree or in Legal Profession with a degree in Law or any other professional degree (to be recognised as a professional degree in this country) is eligible to be a member of this Lodge; However this restriction will not be applicable in the case of a Tyler, who shall be a Master Mason and a subscribing member of any Lodge in India.
