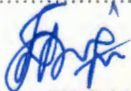

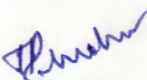
Existing By-Laws	Amended By-Laws
By-Law No. <u>6 - Fees and Subscription</u> cii) Such annual dues payable to the Regional Grand Mark Lodge of Southern India as may be fixed from time to time. The above subscription shall be payable in advance each year. A candidate for Advancement, Joining / Re-joining at any part of the year shall pay the full annual subscription together with the admission fee for Advancement or Joining / Re-joining as the case may be. Honorary Members are not liable to pay any fees. d) If a Serving Brother is elected as a Tyler, he may either be exempted from paying his regular lodge subscription or he may be paid such remuneration for every meeting he attends as the lodge may vote from time to time.	By-Law No. <u>6 - Fees and Subscription</u> The above subscription shall be payable in advance each year. Honorary Members are not liable to pay any fees. d) If a Serving Brother is elected as a Tyler, he may either be exempted from paying his regular lodge subscription or he may be paid such remuneration for every meeting he attends as the lodge may vote from time to time.

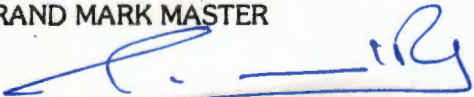

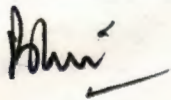
