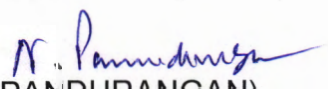

By-Law No. <u>7</u> The Annual Subscription of a resident member shall be Rs. 600 and that of a non-resident member shall be Rs. 400, and in addition, which includes dues to the Regional Grand Lodge of Southern India, dues to the Grand Lodge of India and contribution to Lodge Stewards Fund @ Rs. 200 each member shall be added and become due and payable on the first of every March.	By-Law No. <u>7</u> The Annual Subscription of a resident member shall be Rs. 2250 and that of a non-resident member shall be Rs. 1500; which include all dues to the Regional Grand Lodge of Southern India, the Grand Lodge of India and a contribution of Lodge Stewards Fund as Rs. 250/- shall become due and payable on the first of March each year. There shall be an additional annual collection of Rs. 500/- as premises and building maintenance charges from resident members.
