
Existing By-Laws	Amended By-Laws
<p>By-Law No. 4</p> <p>Candidates for exaltation and Companies desirous of being admitted as members of this Chapter should submit an application in the form approved by the Supreme Grand Chapter of India and Must be duly proposed and seconded at a regular Convocation. No ballot shall take place unless the full name of the candidate, etc., shall have appeared on the summons for the next Convocation.</p> <p>All applications for Exaltation and joining shall first be placed before the permanent committee for recommendation and thereafter will be included in the summons for the next Convocation, when the decision of the members will be declared. Two opposing votes or black balls will negative the proposal.</p>	<p>By-Law No. 4</p> <p>Candidates for exaltation and Companions desirous of being admitted as members of this Chapter should submit an application in the form approved by the Supreme Grand Chapter of India and must be duly proposed and seconded by qualified members of the Chapter and such proposition may take place at a regular convocation or by notice in writing transmitted by the proposer to the Scribe E at least fourteen days before the Convocation. The proposals shall be placed before the Permanent Committee for approval latest at its meeting immediately preceding the meeting at which the ballot is to take place.</p> <p>The date of proposal of a candidate for exaltation or joining shall be specified in the summons for the meeting at which the ballot is to take place. Three Opposing votes or black balls will negative the proposal.</p>







<p>By-Law No..... 6</p> <p>Every companion shall pay a subscription of Rs. 15/- per Quarter. The Subscription will be paid in advance.</p> <p>(a) If any companion is in arrears of Subscription to his Chapter for a year, the scribe shall advise him of the Registered post and if the full amount be not paid within thirty days from the date, he shall be excluded in accordance with Reg. 75 of R.A. Regulations.</p> <p>(b) If the subscription of the Companion to his chapter remains unpaid for two full years, at the expiration of the period he shall cease to be a member of the Chapter and the fact shall be reported to Chapter at its next regular convocation and recorded in the minutes.</p>	<p>By-Law No..... 6</p> <p>Every Companion shall pay a subscription of Rs. 250/- per month.
