
## SUB:AMENDMENT TO BYE-LAWS OF LODGE TIRUPUR NO.324

<p><u>Bye Law Item No.4 - Existing.</u> <u>Subscription &amp; Fees:</u></p> <p>The Annual Subscription of the Member shall be Rs.1800/- made up of Rs.350/ towards General Fund and Rs.1450/- towards Steward Fund payable on or before August. In addition, each member shall pay the GLI &amp; RGL annual dues, as applicable from time to time</p> <p>(amended on 29-11- 2011)</p>	<p><u>Proposal</u></p> <p>The Annual subscription of the Member shall be Rs.2500-00 made up of Rs.500/ towards General Fund and Rs. 2000/ towards Steward Fund, payable on or before August. In addition, each member shall pay the GLI &amp; RGL annual dues, as applicable from time to time.</p>
<p><u>Bye law Item No.3 Existing</u> <u>Day of the Meetings:</u></p> <p>The Regular Meetings of the Lodge shall be held at Poppy's Hotel, Thirumuruganpoondi, Tirupur on the last Tuesdays of all the months of the year (January to December) or at such hour as the Master may, from time to time.</p> <p>( amended on 23-06-2012 )</p> <p>Explanation: To conduct the Meetings at the center of TIRUPUR City for the convenience of the members.</p> <p>The administrative &amp; steward expenses have gone up considerably. Hence the present increase is suggested.</p>	<p><u>Proposal</u></p> <p>The Regular meetings of the Lodge shall be held at MKM HOTEL RICH, Ravapuram Main Road, or any other place at Tirupur, on the last Tuesdays of all months of the year (January to December) or such hour as the Master may, fix from time to time.</p>






