The Tyler and the Treasurer shall also be elected at the regular meeting of the Lodge held in March</p>	<p>Bye-Law No.2</p> <p>The Regular Meetings of the Lodge shall be held in T.D.Arunachalam Hall, Tenkasi on the last Saturdays in the months of February, April, June, July, August and November at such hours as the Master decides</p> <p>Bye-Law No.4</p> <p>The Fees and Subscription shall be as follows and payable in advance ( the official year of the Lodge shall be the English calendar year)</p> <p>a) The Annual Subscription shall be Rs.300/- per year and Stewards Fund Rs.300/- payable in advance on the 1st January of each Calendar year. Over and above each Member shall pay an amount equivalent to dues payable to Grand Lodge of India and the Regional Grand Lodge of Southern India respectively as stipulated from time to time and the same shall be payable in advance on 1st January of each year.</p> <p>a) Initiation Fee Rs.2000/-  b) Joining &amp; Rejoining Fee Rs.2000/-</p> <p>Bye-Law No.9 Elections</p> <p>The Worshipful Master shall be elected by ballot at the regular meeting held in November and he shall be installed at the meeting held in February.
