
**SUB:AMENDMENT TO BYE-LAW NO.30 OF




PROPOSED AMENDMENTS TO/ REVISED BY LAWS


Existing By-Laws	Proposed amendments to By-Laws
By- Law No. 30 Subscription and Fess 30 A member shall pay an annual subscription of Rs.450 and an amount of Rs.750 per annum towards stewards' fund, both payable before 30th June every year, along with actual RGL and GLI dues, otherwise the amount payable will be treated as arrears. If such arrears are not cleared before 30th December every year the membership will cease under rule 124 of BOC. The initiation/ Joining and Rejoining fee shall be Rs.2000 to be paid along with the subscription, steward charges and RGLSI and GLI Dues.	By- Law No. 30 Subscription and Fess 30 A member shall pay an annual subscription of Rs.700 and an amount of Rs.1400 per annum towards stewards' fund, both payable before 30th June every year, along with actual RGLSI and GLI dues, otherwise the amount payable will be treated as arrears. If such arrears are not cleared before 30th December every year membership will cease under rule 124 of BOC. The initiation/ Joining and Rejoining fee shall be Rs.2000 to be paid along with the subscription, steward charges and RGLSI and GLI Dues.

The above amendments were regularly Proposed and Seconded in open Lodge at a regular Meeting held on **15.07.2023** Passed at a regular Meeting held on **19.08.2023** and confirmed at a regular Meeting held on **16.09.2023**






