

<p>Bye-law No. 4</p> <p><b>SUBSCRIPTION:</b> Every Resident member shall pay an annual subscription of Rs. 500 and Steward fund of Rs. 100 and every non-resident member shall pay an annual subscription of Rs. 250 and Steward fund of Rs. 100 to the lodge. In addition to the above both Resident and Non-resident members shall also pay the Annual dues to the Grand Lodge of India and to the Regional Grand Lodge of Southern India as applicable from time to time.</p>	<p>Bye-law No. 4</p> <p><b>SUBSCRIPTION:</b> Every Resident member shall pay an annual subscription of <b>Rs. 800</b> and Steward fund of <b>Rs. 650</b> and every non-resident member shall pay an annual subscription of <b>Rs. 400</b> and Steward fund of <b>Rs. 650</b> to the lodge. In addition to the above both Resident and Non-resident members shall also pay the Annual dues to the Grand Lodge of India and to the Regional Grand Lodge of Southern India as applicable from time to time.</p>
