1.	<p>Members :</p> <p>The members of the Lodge shall comprise of following 3 (Three) categories:</p> <p>(a) MEMBERS:</p> <p>Explanation: Members shall pay the subscription as prescribed in the By-laws.</p> <p>(b) Honorary Members</p> <p>Explanation: Honorary Members are those who are elected as such for services rendered to Masonry in general or to this Lodge Mangalore in particular.</p> <p>(c) Life Members</p> <p>Explanation:</p> <p>(i) Life membership of our Lodge shall be open to a Brother who has been continuously a member for 20 (Twenty) years or more and attained the age of 55 (Fifty five) years.</p> <p>(ii) A lump-sum subscription, equivalent to the 10 (ten) years subscription, at the current rate shall be payable by a Brother who is under 60 (Sixty) years of age</p> <p>(iii) A lump subscription equivalent to 5 (Five) years subscription shall be payable, if the Brother is over 60 (Sixty) years of age.</p> <p>(iv) In the case of a brother with a continuous membership of 20 (Twenty) years in more than one Lodge the lump sum subscription payable shall be 50 percent more than in clause (ii) & (iii) as above</p> <p>(v) The life member however shall continue to pay the annual G.L.I and R.G.L dues as before.</p> <p>Note to clause (v): However, such a life member, can also pay the G.L.I & R.G.L life membership dues as a lump sum subscription as demanded at that time, along with the Lodge Mangalore subscription.</p> <p>(vi) The subscription to the Stewardship Fund shall be payable by the Life members, on the days of their attendance in the Lodge.</p>	<p>Members :</p> <p>No Change</p> <p>(i) No Change</p> <p>(ii) No Change</p> <p>(iii) No Change</p> <p>(iv) No Change</p> <p>v) The life member however shall continue to pay the annual G.L.I and R.G.L dues as before.</p> <p>(vi) No Change</p>
2.	<p>Days of Meeting:</p> <p>(i) The Regular Monthly meeting of the Lodge shall be held on the last Saturday in every month at 6-30 P.M. at the premises if the Lodge at Mangalore, but it may be held at some other day or place under dispensation from the Regional Grand Lodge. The Meeting can be called at an earlier hour, if necessary provided separate circular on the summons is also sent to every member.</p> <p>(ii) Summons for convening the Regular Meeting of the Lodge shall be issued at least seven days previous to such meetings.</p>	<p>Days of Meeting and Venue:</p> <p>(i) The Regular Monthly meeting of the Lodge shall be held on the last Saturday in every month at 6-30 P.M. at the Freemason's Hall, Masonic Valley, Bolpugudde, Kavoov, Mangalore - 575 015, but it may be held at some other day or place under dispensation from the Regional Grand Lodge. The Meeting can be called at an earlier hour, if necessary provided separate circular on the summons is also sent to every member.</p> <p>(ii) No Change</p> <p>(iii) Dispensation for change of date & time of regular monthly meeting to be obtained at the request of the Master only for valid reasons to be brought to the Standing committee to be approved, In case of emergency, the Master can take dispensation to change the date & time by informing the Standing committee</p>

3.	<p>Subscription and Fees:</p> <p>(i) a) Every member shall pay Rupees Forty (Rs. 40/-) per month in advance as subscription to the Treasurer on or before the day of the regular meeting. A brother who has not paid his subscription before the regular meeting shall be considered to be in arrears for that month. The money may be paid in cash or crossed D.D. or by crossed cheque with extra Rs. 20/- (Rupees Twenty only) added as Bank charges, for outstation cheques.</p> <p>b) Apart from the Lodge dues as above as in 3.(i) a. the member also has to pay the other dues as applicable, as mentioned below:- "Y"- Annual dues to the Regional Grand Lodge of Southern India; by all the members: - Rs. 40/- (Forty per quarter) Rs. 160/- per year, (2002). "Z" - Annual dues to the Grand Lodge of India by all the members - Per Year - Rs. 200/- (Two hundred), (2002).</p> <p>Note: The above dues of 3. (i) b: "Y", "Z" dues are to be collected by the Lodge and the amount shall be as prescribed from time to time by the R.G.L. and G.L. of India.</p> <p>(ii) The expense of any Emergency Meeting and the Dispensation fee, if any, due to the Regional Grand Lodge, shall be borne by the Brother or Brethren at whose instance the Meeting is held or dispensation obtained.</p> <p>(iii) The following fees shall be payable in advance in every case, before balloting for :</p> <p>(a) for Initiation, Passing or Raising- Rs. 300/- (Three hundred)</p> <p>(b) for Joining from Foreign Constitution-Rs. 100/- (One hundred)</p> <p>(c) for Joining and Rejoining -Rs. 100/- (One hundred)</p> <p>(d) Every candidate before balloting shall pay a sum of Rs. 3,000/- (Three Thousand only) for the Lodge Building improvement and Maintenance Fund.</p> <p>(iv) Steward's Fund Account: A sum as determined by the Standing Committee from time to time and not exceeding Rs. 250/- (Rupees Two Hundred & Fifty only) per month is to be collected for each member for the cost of the after proceedings. This amount shall be payable by Ordinary Resident Member of D.K. District.</p>	<p>Subscription and Fees:</p> <p>(i) Every member shall pay to the Treasurer the following dues of the lodge, as mentioned in schedule 3(iii) d, e, f, g actuals of which may be changed and presented from time to time and approved in the open lodge. The dues may be paid in cash or crossed cheque drawn in favour of "Lodge Mangalore No. 156" to the Treasurer who shall issue a receipt forthwith. In addition to this, a member shall pay Rs.10,000/- towards Lodge building and Maintenance fund while joining the lodge as one time contribution.</p> <p>A member in arrears of subscription for a period of one year will be under automatic cessation as per Rule No. 124 of the Book of Constitution. He also ceases to be a member other lodges under G.L.I.</p> <p>(ii) The dues payable to the Lodge towards subscription, Steward Fund and towards Building Fund may be changed after discussion in the Standing Committee, proposed in the open lodge and passed by a 2/3 majority of the members present and voting during a regular meeting of the lodge or during an Emergency meeting of the lodge when called for the purpose. The new approved dues to come into effect for the following year starting 1st September <i>after being approved by V.K. 4	<p>Admission of Members:</p> <p>(i) Every proposition for initiation or joining or rejoining shall be made in open lodge.</p> <p>(ii) The proposition together with the declaration shall be referred to the standing committee for consideration and report to the lodge.</p> <p>(iii) Subject to the provisions of Rule 135 of the Book of Constitutions G.L.I., no candidate shall be initiated in or admitted or re-admitted into the lodge until he shall have been regularly proposed and seconded at a regular meeting and balloted for at the next Regular Meeting.</p> <p>(iv) When the ballot takes place for the election of a candidate for initiation or joining or rejoining of a Brother that no person shall be made a mason in or admitted as a member of the Lodge, unless if on the ballot two thirds of the members present and voting in the lodge approve the proposal for such a candidate. A rejected candidate shall not be proposed until; one year, after such rejection.</p> <p>v) If a candidate for Initiation, Joining or Rejoining is rejected by the ballot; he shall not again be proposed until Twelve months have elapsed after the date of the unfavourable ballot.</p>	No Change
5.	<p>Resigning and Defaulting Members:</p> <p>(i) Any member desirous of resigning from the Lodge shall signify the same in writing to the Secretary before the regular meeting in a month, or announce it in the open lodge.</p> <p>(ii) A brother resigning his membership relinquishes his rights in the Lodge, and shall be re-admitted only on payment of arrears if any along with re-joining fees subject to passing the ballot.</p> <p>(iii) When the subscription of any member falls into arrears to the extent up to six months, he shall be liable for exclusion in accordance with Rule 156 - Book of constitution G.L.I.</p> <p>(iv) Rule 124 of the Book of Constitution G.L.I, states that should the subscription of a member to any Lodge remains unpaid for ONE full year; at the expiration of the period he shall cease to be a member of all Lodges. 6.	Election of Master, Tyler and Treasurer: The Master, Tyler and the Treasurer shall be elected at the Regular Meeting in the month of August every year	No Change
7.	Installation Meeting: (i) The Master shall be installed at the Regular Meeting in September (ii) The Installation Meeting shall be managed by a Committee appointed for the purpose at the Election Meeting. The Committee shall consist of the Master, the Master Elect, the Secretary, the Treasurer and two or more other Members to be nominated by the Master. 8.	Duties of Tyler: He shall be in charge of all paraphernalia belonging to the lodge and be responsible for the proper preservation thereof and shall keep an inventory of it, countersigned by the Master once a year after his Installation. 9.	Property and Funds of the Lodge Property of every kind belonging to the Lodge (including the Warrant, Jewels, Regalia and Archives) shall be considered as vested in the Master, and the Wardens. The responsibility will handed over to their successors at the installation meeting. A regular inventory of the whole shall be entered in a separate book and examined by each Master after his installation No property of the lodge shall be sold or otherwise disposed of, except by resolution of the Brethren in open lodge	No Change
10.	Charity Fund: (i) The charity fund of the Lodge shall be maintained by the monthly charity box collection made in the Lodge. Voluntary contributions may also be made by members of the Lodge Mangalore and other brethren. (ii) The charity fund is intended for the purpose of giving relief to members of this Lodge and their families and for such relief purposes as the Lodge may from time to time decide upon by a majority of not less than two thirds of the members present. Relief may also be given to brethren who were or have been subscribing members of the Lodge Mangalore for a period of not less than five consecutive years, or their afflicted widows, mothers and children. (iii) Every application for such relief must, in the first instance, be referred by the Lodge to the Standing committee for consideration and report to the Lodge. (iv) In cases of emergency, it shall be competent for the master to straight-away sanction payment of a sum of not more than Rs.250/- (Two Hundred & Fifty) previous to reporting to the Lodge. This item shall appear in the Agenda in the Summons.</p> <p>(iii) It shall not be competent for the Brethren to abrogate, amend or alter these By-laws unless the abrogation, amendment or alteration shall have been duly proposed and passed at one Regular meeting, inserted in the summons of next regular meeting and read and confirmed in the open lodge and subsequently approved by the Regional Grand Master and the Grand Master. The By-laws must then be printed and a copy sent to the Grand Secretary and the Regional Grand Secretary and to all the Brethren of Lodge Mangalore.</p>	No Change


