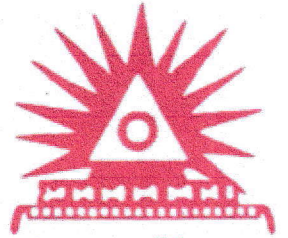

Subscription</u> Subscription shall be Rs.600/- (Rupees Six hundred only) per year every companion and fee payable effect that he is full possession of all his Masonic Privileges are Supreme Grand Chapter and Regional Grand Chapter as prescribed by them. If any companion fails to pay the subscription due for one year, he shall be liable for exclusion in accordance with the Book of constitutions (craft). The year of the Chapter shall be from 1st of September to 31st of August of the succeeding year.</p>	<p><u>9. Subscription</u> Subscription shall be Rs.1,000/- (Rupees One thousand only) per year every companion and fee payable effect that he is full possession of all his Masonic Privileges are Supreme Grand Chapter and Regional Grand Chapter as prescribed by them. If any companion fails to pay the subscription due for one year, he shall be liable for exclusion in accordance with the Book of constitutions (craft). The year of the Chapter shall be from 1st of September to 31st of August of the succeeding year.</p>
