By-Law no.2 OFFICERS: The office bearers of the Lodge shall consist of -----	By-Law no. 2 The Office bearers of the Lodge shall consist of: Worshipful Master; I.P.M.;Sr.Warden;Jr. Warden;Chaplain;Treasurer; (elected); Secretary: Director of Ceremony; 5 no. BVSL; Sword Bearer; Asst.DOC; Almonar;Organist; asst. Secretary Inner Guard;Stewards not exceeding 5 and Tyler (elected).
By-Law No.3 The Regular Meeting day of the Lodge shall be the first Wednesday of every alternate month beginning with February of every year.	By-law No.3 the Regular Meeting of the Lodge shall be the first Wednesday of every month except May, beginning with January of every year.
By-Law No.4 Members: The Lodge wil consist of Resident,absent, Honorary and Life Members.	By-law No.4 Members:The Lodge will consist of Resident,Absent, Non resident, Honorary and Life members.
By-Law No.5 Limits of Jurisdiction:	By Law No.5 Limits of Jurisdiction: The word "Station" shall be held to mean the limits of the Greater Hyderabad Corporation/ Notified Hyderabad Urban Development and as amended from time to time.
By Law No.7 LIABILITY OF PROPOSER AND SECONDER:	By Law No.7 LIABILITY OF PROPOSER AND SECONDER: The Proposer and Seconder shall both be individually/jointly responsible for all fees and expenses incurred on account of such Brother till he becomes full fledged Master Mason or for a period of one year whichever is greater.
By Law No.9 BALLOT.....	By Law No.9 BALLOT: No person shall be made a Mason in or admittted of a Daughter Lodge unless if on Ballot, two third of the members present and voting in the Lodge approve the proposal for such candidature.
By Law No.12 B: Nil	REBALLOTING: ANY CANDIDATE REJECTED UNDER RULE 149 shall not be repropsoed and Ballotted unless 3 months period has lapsed between the 1st and Re balloting.

Bye Law No.16 For the existing last sentence in the said Bye law which reads 'This rule unless reasonable <u>Excuse</u> be adduced to the contrary.	Bye Law No.16 For this existing sentence in the said Bye law is now to be read as "This rule unless reasonable evidence be <u>adduced</u> to contrary.
Bye Law No.17: FEES AND SUBSCRIPTIONS:	Bye Law No.17A FEES AND SUBSCRIPTIONS:The following fees shall be payable in advance to the Lodge and such fees shall not include cost of M.M.apron,G.L.I. AND R.G.L. dues, but includes Certificate fee to every mason. INITIATION Rs. 1,000.00 JOINING OR REJOINING: Rs. 500.00 Supply of M.M.Apron: at actuals. Monthly subscription including dinner: Rs.150.00 Absent Member: Rs.50.00 G.L.I. And R.G.L.Dues at actuals
Bye Law No.17 B No provision in the By Law.	Bye Law No.17 B: LIFE MEMBER: Any member who has reached the age of 50 years and has been a subscribing member of the Lodge for 20 years is eligible to become a Life member by the Payment of 5 times yearly subscription in one lumpsum or 3 instalments in a year.
Bye law No.19: Should the subscription of a member remains unpaid for 6 months, Secretary will send a notice to him requesting settlement within 1 month from date thereof.	Bye Law No.19: If the subscription is not paid within the year for which it is due and the Member is in arrears in the following year he automatically ceases to be a Member of the Lodge as per Bye-law 124 of the Book of Constitution of the GLI.
Bye Law No.21: EMERGENT CASES OF DISTRESS: A sum of Rs.500 from Benevolengt Fund shall be annually held at the disposalof the W.M. to meet emergent cases of distress.	Bye Law No.21: a SUM OF Rs.1,000 from the Benevolent fund shall be annually held at the disposal of the W.M.to meet emergent cases of disress.
Bye Law No.23: EXTRA FEES: It shall be within the discretion of tshe Lodge to levy a fee not exceeding Rupees Thirty at any time that circumstances may require it.	Bye Law No.23: EXTRA FEES: It shall be within the discretion of the Lodge to levy a fee not exceeding rupees One Hundred at any time that circumstances may require it.


