
Existing By-Laws	Amended By-Laws

Existing Bye-Law No.7 : Subscription The Annual Subscription shall be Rs.100/- payable in advance on 1st January of each year, plus amount payable per member to the Grand Lodge and Regional Grand Lodge of Southern India annually.	Proposed Amendment Bye-Law No.7 : Subscription The Annual Subscription shall be Rs.200/- payable in advance on 1st January of each year, plus amount payable per member to the Grand Lodge of India and the Regional Grand Lodge of Southern India annually. Of this amount of Rs.200/-, a sum of Rs.100/- will be toward the Journal Account of the Lodge to help support the printing, publishing and other expenses related to the Madras Masonic Journal.






