Existing by Laws

By-Laws No... 7.....

- a) subscription for resident members shall be rs.400/ per annum
- b) subscription for resident members shall be rs.120/ per annum
- c) fee for initiation shall be rs. 1000/- .this is inclusive of all fees payable by the lodge to the grand lodge and regional grand lodge.
- d) fee for joining or rejoining from the Indian constitution shall be rs.500/- fee for joining from a lodge under recognized constitution shall be rs.600/-

Amended By -Laws

By-Laws No... 7.....

- a) subscription for resident members shall be rs.600/ per annum.
- b) subscription for resident members shall be rs.600/ per annum.
- c) fee for initiation shall be rs. 1500/- .this is inclusive of all fees payable by the lodge to the grand lodge and regional grand lodge.
- d) fee for joining or rejoining from the Indian constitution shall be rs. 750/- and fee for joining from a lodge under recognized constitution shall be rs.750/- (seven hundred and fifty only)
- e) a new clause has to be added after 11.7d as 11.7e as follows
a new member whether joining or initiated into the lodge shall pay a contribution of rs 15000/- towards building fund as a lump sum or in installments as directed by the permanent committee.

By-Laws No. 9 (d)

Two black balls shall exclude a candidate and any one so excluded shall not be proposed again until six months after the date of balloting.

By-Laws No. 9 (d)

No person shall be made a mason or admitted unless if on ballot two thirds of the members present and voting in the lodge approve the proposal of such candidate. any person not so approved shall not be proposed again until 6 months have elapsed after the date of his rejection.
