

Bye Law No. 43 Standing Committee : There shall be a Committee styled the " Standing Committee " of the Lodge which shall consist of the Worshipful Master, all Past Masters, Past Wardens, the Senior & Junior Wardens, the Secretary, The Treasurer, the Director of Ceremonies, the Senior & Junior Deacons, the Asst Secretary, Asst Director of Ceremonies , the Inner Guard , the Almoner and any SEVEN of the said Standing Committee shall form a Quorum.	Bye Law No. 43 Standing Committee : There shall be a Committee styled the " Standing Committee " of the Lodge, which shall consist of the Worshipful Master, the IPM, the Senior & Junior Wardens, the Secretary, the Treasurer, the Director of Ceremonies, the Senior & Junior Deacons, the Asst Secretary, the Asst Director of Ceremonies, the the Inner Guard, the Almoner and any two Past Masters or Past Wardens duly elected by the Lodge at the Installation Meeting and any five of the said Standing Committee shall form a quorum.


