<p>By-Law No. <u>4</u></p> <p>The annual subscription payable by the members shall be: Rs. 1,000/- plus annual dues to Grand Lodge of India and Regional Grand Lodge of Southern India as may be applicable from time to time. All subscriptions to be paid in advance.</p> <p>Out of the Annual Subscription collected from members, a sum of Rs. 500/- be allocated to the Stewards Fund and the same shall be transferred to the 'Lodge Shanthi Stewards' Fund bank account to be operated by any two of the following viz. The W. Master, Treasurer and the Secretary. The dinner charges, at only the Regular Meetings, be defrayed from out of the 'Stewards' Fund.</p>	<p>By-Law No. <u>4</u></p> <p>The annual subscription payable by the members shall be: Rs. 1,000/- plus the annual dues payable to Grand Lodge of India and Regional Grand Lodge of Southern India as may be applicable from time to time. All subscriptions shall be paid in advance.</p> <p>Out of the Annual Subscription collected from members, a sum of Rs. 100/- shall be allocated to the Stewards Fund and the same shall be transferred to the Lodge Shanthi Stewards Fund bank account to be operated by any two of the following viz. the Master, Treasurer, and the Secretary. The dinner charges of visitors to the Lodge at only the regular meetings (excluding Installation Meetings) may be defrayed from out of the 'Stewards' Fund.</p> <p>By-Law No. <u>4a</u> (addition)</p> <p>The accounting year of the Lodge shall be from the 1st November to 31st October of the succeeding year. The subscription from Members shall be received before 31st of October of the concerned year.</p>
