# BYE-LAWS OF The Bharathi Lodge No. 161

## I. Members

1. The Members of the Lodge shall comprise of three classes, viz:-

(a) Resident members, (b) Non-Resident Members, (c) Honorary Members.

*Explanation 1.* - Resident members are those who reside within 100 kilometers radius of Pondicherry.

*Explanation 2.* - Non-Resident members are those who reside beyond the said limit and apply, in writing, to the Secretary or express their desire in the open Lodge that they be brought in the non-resident list.

*Explanation 3.* - Honorary members are those who are elected, as such, for services rendered to Masonry in general or to this Lodge in particular.

2. Resident members shall be placed on the Non-resident list from the month following that in which the application to the brought in that list is made in accordance with the provisions of Rule 142 of the Book of Constitution.

## II. Days of Meetings

3. The regular Meeting of the Lodge shall be held at the Masonic Temple Pondicherry, on the last Saturday of every month at such hour as the Master may, from time to time, direct.

4. Summons for convening the Regular Meeting of the Lodge shall be issued at least seven days prior to such meeting.

## III. Subscriptions and Fees

5. The annual subscription of a resident member shall be Rs. 600/- and that of a non-resident member shall be Rs. 400/- and, in addition, all dues to the Regional Grand Lodge of Southern India and dues to the Grand Lodge of India shall be added and become due and payable on the first of every March.

6. The following shall be the fees payable in advance :

Initiation	1000/-
Joining	1000/-
Joining from other Constitutions	1000/-
Rejoining	1000/-

7. The expenses of any Emergency Meeting and Dispensation Fee, if any, due to the Regional Grand Lodge, shall be defrayed by the Brother or Brethren at whose instance the meeting is held or Dispensation obtained.

## IV. Admission and Retirement of Members

8. (i) No candidate for Freemasonry shall be initiated, and no Brother shall be admitted as a joining member of the Lodge if, on the ballot, three black balls appear against him.

(ii) If the Master is of the opinion that a mistake might have occurred in the ballot, he may order for a second ballot to be taken forthwith, which shall be final.

9. A candidate rejected for initiation or joining shall not be again proposed in the Lodge until after a lapse of six months from the date of the last ballot.

10. Any member, whose subscription for a period of 3 months or more remains unpaid, shall be liable to exclusion under the provisions of Rule 156 read with rule 124 of the B of C and shall be deprived, while so in default, of the rights of voting, proposing or seconding candidates and being appointed or elected to any office. In any other, case provision of Rule 124 will apply.



11. A member, who has resigned or has ceased to be a member or has been excluded for non-payment of dues, shall be permitted to rejoin only on payment of all previous arrears together with his rejoining fee, shall be subjected to a fresh ballot.

#### **V. Elections, etc.,**

12. The Master shall be elected at the Regular Meeting in January and shall be installed at the next Regular Meeting in February.

13. The tyler & Treasurer shall be elected at the Regular Meeting in January.

14. No motion shall be made or discussed in the Lodge which is not mentioned in the summons, unless, in case of emergency, the Master directs otherwise.

15. No question, once decided in open Lodge, shall be raised again for a second time without the permission of the Master and until 3 months shall have elapsed after its last decision.

16. The control of the property of the Lodge shall be as provided in Rule 119 B. of C.

17. At the Regular Installation Meeting, the Lodge shall appoint a Standing Committee, consisting of the

Master, Immediate Past Master, Wardens, the Secretary, the Treasurers and two other members.

18. At the Regular Installation Meeting the Lodge shall appoint the Audit Committee of the two members referred to in Rule 130 of the Book of Constitution.

#### **VI. Standing Committee**

19. The duties of the Standing Committee, appointed by the Lodge, shall be to enquire about and report on candidates for initiation and joining, to examine the Secretary's books and check the Treasurer's accounts, to inspect and check all the property of the Lodge, at least once a year and to submit at the Regular Meeting in February, before the Installation of the Master-elect, an Annual Report, of the financial condition and upon general questions affecting the Lodge during the period under review.

#### **VII. Secretary**

20. The Secretary of the Lodge shall be ex officio Secretary to all Committees appointed by the Lodge.

21. All letters from members of the Lodge shall be addressed to the Secretary.

22. The Secretary shall conduct all the general business and look after all the correspondence of the Lodge. He shall issue summons for or notices of all meetings of the Lodge or Committees, record minutes of their proceedings and keep the register of members and all other registers and records, except the accounts kept by the Treasurer. He shall carefully preserve all books and records, and keep a register of all moneys passing through his hands. He shall, immediately, if they are due, prepare the Returns for the Grand and Regional Grand Lodges and forward them, through the Master, together with all fees and contributions due thereon, to the authorities concerned.

### **VIII. Treasurer**

23 (i) The Treasurer shall have charge of and be responsible for the money and the account books of the Lodge. He shall receive direct all moneys due to or held for the Lodge and deposit the same in the name of the Lodge at a bank approved by a resolution of the Lodge and shall make payments for current ordinary expenses on the authority of the Master or other Officer-in-charge of the Lodge. All payments shall be made by cheques, The Treasurer, together with the Master and / or Secretary, shall operate the Bank Account on behalf of the Lodge. No other payment shall be made by

cheques. Any two of the Treasurer, the Master and Secretary, shall operate the Bank Account on behalf of the Lodge. No other payment shall be made without a resolution of the Lodge. He shall submit his account at the Regular Meetings of the Lodge. He shall be given imprest cash not exceeding Rs. 500-00 for defraying contingent expenses of the Lodge.

(ii) The accounts of the Lodge shall be maintained under the following distinct and separate heads :

1. General Account
2. Charity Account
3. Building Fund

24. A sum of 500-00 from the General Fund of the Lodge, shall be annually placed at the disposal of the Master to meet emergent cases of distress. In case, the Master exercises this privilege, he shall report the circumstances at the next Regular Meeting of the Lodge; otherwise the sum shall at the close of the year, be carried over to the Charity Account.

25. All ordinary cases of distress shall be submitted for discussion in open Lodge.



## IX. Alteration of Bye Laws

26. It shall not be competent for the Brethern to abrogate, amend or alter these Bye-laws unless the abrogation, amendment or alteration shall have been duly proposed and passed at one Regular Meeting, after insertion in the summons, and read and confirmed at the next Regular Meeting; but no such amendment or alteration shall come into force until the same is approved by the Regional Grand Master and the Grand Master.
