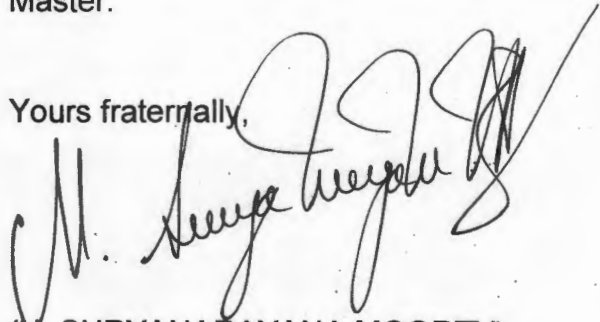

Existing By-Laws	Amended By-Laws
By-Law No. <u>25 & 26</u> <u>BY LAW NO. 25.</u> A sum of Rs 25/- from the general funds of the Lodge shall be annually placed at the disposal of the Master to meet emergent cases of distress. In case the Master exercises this privilege, he shall report the circumstances at the next Regular meetings of the Lodge, otherwise the sum shall at the close of the year be carried to the charity fund. <u>BY LAW NO. 26.</u> A sum of Rs 25/- from the General Funds of the Lodge shall be paid to the Secretary as Imprest cash to meet petty expenses and which shall be reimbursed by the Treasurer on the Secretary rendering to him the accounts of such expenses.
