

<p>The regular meetings of the Lodge will be held on the penultimate date of January, February, <del>March</del>, April, July, August, <del>September</del>, October &amp; November.</p> <p>When the regular meeting falls on a Sunday it shall be held on the previous or next day to that date.</p> <p><b>Explanation :</b> Considering the difficulty expressed by most of the brethren when a meeting is held on a working day, which normally occurs when it is penultimate date of the month, the PC recommended amendment to the above bye law regarding the fixed day/date of the meeting namely 4<sup>th</sup> Saturday of every month except May, June &amp; December.</p>	<p>The regular meetings of the Lodge will be held on the 4<sup>th</sup> Saturday of January, February, <del>March</del>, April, July, <del>August</del>, September, October &amp; November.</p> <p>-- Deleted --</p>


