**BYE - LAWS**

## **1. Regular Meetings**

The Regular meeting of the Lodge shall be held on the 4<sup>th</sup> Sunday in the months of February, May, August and November at Freemasons Hall, Vazhudacaud, Trivandrum.

## **2. Election of Officers**

The election of the Master and the Treasurer shall be by Ballot at the Regular Meeting in May. The Tyler shall be chosen by show of hands at the same meeting. The installation of the Master and the investiture of Officers shall be at the next Regular Meeting in August.

## **3. Duties of Secretary**

The Secretary shall, have charge of the general correspondence, issue summons for all convocations, record minutes of the proceedings and keep the registers required by the regulation of the Grand Lodge of Mark Master Masons, as well as all registers and records prescribed by the Regional Grand Mark

Lodge Bye-Laws. He shall also preserve all other necessary records and keep an account of all money passing through his hands.

## **4. Duties of Treasurer :**

The Treasurer shall have charge of and be responsible for the money; account books of the Lodge. He shall receive from the Secretary all collections of every kind and deposit them in a Bank as decided upon in open Lodge. He shall at every regular meeting present his accounts, which after approval by the members shall be incorporated in the minutes of the proceeding of the meeting. He may have Rs. 1,000/- (Rupees Thousand only) as imprest money in his possession for contingencies. All cheques will be signed by the Treasurer and either of the Master or Secretary of the Lodge.

## **5. Duties of Registrar**

The Registrar shall be bound to see that the name of the members of the Lodge, those advanced and those admitted as joining member with their ages, the

## 10. Annual Subscriptions

The annual subscription shall be Rs. 300/- (Three Hundred only) per year for every member. In addition to the above, prescribed dues payable to the Grand Mark Lodge and to the Regional Grand Mark Lodge shall be payable by each member as applicable from time to time. The accounting year shall be from 1<sup>st</sup> August to 31<sup>st</sup> day of July. If any member fails to pay the subscription due for one year, he will be liable for exclusion in accordance with rule 110 of the Book of constitutions.

11. No motion to add, to alter, or amend the foregoing bye-laws or any of them shall be made without first giving notice of such motion in writing to the secretary and notice there of to be inserted in the summons for the next regular meeting. All notices of motion shall be sent to the secretary at least 14 days before the meeting at which it is intended, they shall be discussed. No bye-law, when altered, shall take effect until it has been confirmed at the next regular meeting and approved by the Regional Grand Master and the Grand Master.

## 12. General :

In all matters, the member shall abide by, and strictly conform to, the laws and Regulations of the Grand Lodge, and in all matters not expressly herein before provided for, the directions contained in the book of constitutions, so far as they are applicable there to.
