12. General:

a) Any convocation is held at the specific request of any candidate/candidates for exaltation on any day other than a regular meeting, the cost of the meeting including the hall rent, refreshment fellowship and dinner shall be borne by such candidate/candidates.

d) In the event of any abrogation, amendment or revision of any Byelaw or Bye laws the Scribe E shall provide each member with a copy of thereof after the approval by the RW the Regional Grand Superintendent of Southern India and by the M.W. the Supreme Grand Superintendent.
