By-Law No.VII.5.  The Treasurer shall draw up an Annual statement of accounts showing the receipt and expenditure and balance in cash, securities etc for the year ending 31 <sup>st</sup> March which when audited and found correct by the Audit Committee shall be signed and placed before the Chapter at the Installation meeting in June.	By-Law No.VII.5  The Treasurer shall draw up an Annual statement of accounts showing the receipt and expenditure and balance in cash, securities etc for the year ending 31 <sup>st</sup> March which when audited and found correct by the Audit Committee shall be signed and placed before the Chapter at the Installation convocation in <b>May</b> .






