



By-Law No. 3, 5, 6, 10, 13, 214.	
3. The regular Meeting of the Lodge shall be held at the Free-Masons' Hall Thanjavur on the third Saturday in Januvary, March April July September, October and December at such hour as the Master may from time to time direct.	3. The Regular Meetings of the Lodge shall be held at the Free Masons Hall Thanjavur on the third Saturday in the following months of the year Januvary, February, April, July, August, October and November at such hour as the Master may direct from time to time.
5. The Subscription per half year of a Resident Member shall be Rs. 75 and that of a Non-Resident Member shall be Rs. 60 payable in advance during the first month of every half year being divided in to two half years Januvary to June and July to December	5. (a) The subscription per half year of for both Resident and Non - Resident Members shall be Rs.200: payable in advance on the first month of every half year, the year being divided into two half years Januvary to June and July to December. (b) Each Member (both Resident and Non - Resident ) shall also pay a sum of Rs.150: for each half year to Stewards Account.
6. The following shall be the fee payable in advance: Initiation Rs.230/- Joining from sister Lodges Rs. 75/- Joining from other Constitutions Rs.100/- Rejoining Rs. 50/-	6. Initiation Rs.500/- Joining from <del>sister</del> Lodges under GLI Rs.250/- Joining from other Constitutions Rs.600/- Rejoining Rs.250/-
