Bye-Law No.18

At the Installation Meeting in the month of September every year, the Lodge shall appoint the Committee referred to in Rule 129 of the Book of Constitutions of Grand Lodge of India

Bye-Law No.19

The duties of the Standing Committee appointed by the Lodge shall be to enquire and report on candidates for Initiation and Joining, to examine and check the Treasurer's accounts, to inspect and check all the properties of the Lodge at least once a year and to submit at the Meeting in September before the installation of the Master-elect, an Annual Report of the financial condition of and upon general questions affecting the Lodge during the period under review.

Bye-Law No.5

The annual subscription of a Resident member shall be Rs.750/- and that of a non-Resident member Rs.350/- payable on the first of September every year.

Bye-Law No.18

At the Installation Meeting in April every year, the Lodge shall appoint the Committee referred to in Rule 129 of the Book of Constitutions of Grand Lodge of India.

Bye-Law No.19

The duties of the Standing Committee Appointed by the Lodge shall be to Enquire and report on candidates for Initiation and Joining, to examine and check the Treasurer's accounts, to inspect and check all the properties of the Lodge at least once a year and to submit at the Meeting in April before the installation of the Master-elect, an Annual Report of the financial condition of and upon general questions affecting the Lodge during the period under review.

Bye-Law No.5


The annual subscription of a Resident member shall be Rs.750/- and that of a non-Resident member Rs.350/- payable on the first of April every year






