**WARRANT OF CONSTITUTION
OF LODGE "MORLAND"**

GRAND LODGE OF SCOTLAND

TO ALL AND SUNDRY TO WHOSE KNOWLEDGE These presents shall come, Greeting in God Everlasting.

Whereas upon the Third day of May one thousand eight hundred and seventy-five years, a Petition was presented to the Grand Lodge of Scotland, in the names of William B. Johnston, Charles Kirkman, Joseph Hulme Taylor, Maurice H. Wilkinson, C.B. Dunlop, H. deQ. Sewell, J. Houlihan, and others, PRAYING the said GRAND LODGE to grant a Charter of Constitution and Erection in the usual form, for holding a Lodge under the name and title of "Morland", Secunderabad, Deccan, and PROPOSING the persons after mentioned to be the first Office-BEARERS hereof, viz., William B. Johnston, Right Worshipful Master; Maurice H. Wilkinson, Depute Master; Charles Kirkman, Substitute Master; Charles B. Dunlop, Senior Warden; Joseph Hulme Taylor, Junior Warden; Alexander P. Mergler, Treasurer; J. Houlihan, Secretary; J. Kirby, Senior Deacon; H. deQ. Sewell, Junior Deacon, &c, Which Petition, with the requisite Certificates, therewith produced, having been duly considered in Grand Lodge assembled, they were pleased to ordain a Charter to be issued in the terms underwritten.

Know ye therefore, that the Most Worshipful the Grand Master Mason of Scotland and the Grand Lodge thereof have constituted, erected and appointed, like as they hereby constitute, erect and appoint the Master, Wardens, and Brethren above named to be now, and in all time coming a true and regular Lodge of free and accepted Masons, under the name, style, and title of "Morland", Secunderabad, Deccan, and APPOINT and ORDAIN all regular Lodges to hold and respect them as such GIVING, granting and

committing to them and those to be afterwards admitted members of the said Lodge, full power and authority to meet, assemble and convene as a regular Lodge; AND to enter Apprentices, pass Fellow Crafts, and raise Master Masons, upon payment of such compositions, for the support of their Lodge, as they shall see convenient, but which compositions at their initiation shall not be under the sum of One Pound Six Shillings and Six Pence Sterling; AND with power also annually to elect and choose MASTERS, WARDENS, and other office Bearers, recommending to the Brethren of the said Lodge to reverence and obey their Superiors in all things lawful and honest, as becometh the honour and harmony of Masonry; AND the said Brethren becoming bound on no account to desert their own Lodge; Nor upon any pretext whatever to make any separate or Schismatical meetings, independent of the Master and Wardens, for the time; Nor to introduce any other orders of Masonry than those sanctioned by the Grand Lodge; Nor to collect funds separate from the common Stock of their Lodge, to the prejudice of the Poor thereof.

And declaring that the said Lodge and whole constituent members thereof, now and in all time coming shall, by accepting this present Charter, be bound in faithful allegiance to the said GRAND LODGE as Head of the Masonic Body in Scotland; and shall be obliged to obey and pay due regard to all Acts, Statutes and Regulations of the said Grand Lodge, already made and enacted, or hereafter to be made and enacted, for the utility, welfare and prosperity of Masonry. And generally to pay and perform whatever is required from them for the support and dignity of the Grand Lodge: AND PARTICULARLY to account and pay into the funds of the Grand Lodge, at least the sum of Ten Shillings and Six Pence Sterling for each member initiated in their Lodge from and after the date hereof; which sums they shall cause to be annually remitted to the Grand Secretary, at Edinburgh; and at the same time transmit to him a list of the names of the members initiated, in order that the same may be recorded in the Books of the Grand Lodge; And the Brethren of said Lodge shall be bound to record, in the Books of their Lodge (which Books they are hereby authorised and enjoined to keep), this present Charter, their own regulations and bye-laws, and

minutes of their whole procedure from time to time, so that the same may be better known and more easily observed by the Brethren, Subject always nevertheless to the review and control of the Grand Lodge. AND the said Brethren are hereby required to attend the whole General Meetings and quarterly Communications of the Grand Lodge, by their Representatives, being their Master and Wardens, for the time, or by lawful proxies, in their names (provided such proxies be Master Masons of some established Lodge, holding of the Grand Lodge), so that they, by their said Representatives, may act and vote in the Grand Lodge and be duly certiorated of the proceedings thereof; DECLARING the said Lodge's precedence in the Grand Lodge to be from the date hereof. And for the more effectual preservation of these presents, the same are hereby appointed to be recorded in the Books of the Grand Lodge.

Given at the Grand Lodge of Scotland held in FREEMASONS' HALL in the City of Edinburgh, the Third day of May in the year of OUR LORD One Thousand Eight Hundred and Seventy-five. And of Light Five Thousand Eight Hundred and Seventy-nine. By Sir Michael Robert Shaw Stewart, Baronet, Most Worshipful Grand Master Mason of Scotland; the Right Honorable Walter Henry Earl of Mar and Kellie, Right Worshipful Depute Grand Master; Captain James Townsend Oswald, of Dunnikier, Right Worshipful Substitute Grand Master; Major Hamilton Ramsay, of Garion, Right Worshipful Senior Grand Warden; the Right Honorable George John Lord Rosehill, Right Worshipful Junior Grand Warden; and John Laurie, Esq., Right Worshipful Grand Secretary.

CHARTER

GRAND LODGE OF INDIA

To All and Every our Right Worshipful, Worshipful and
Loving Brethren.

We

SEND GREETING:

Know Ye that Morland Lodge No. 569 on the roll of Grand Lodge of Scotland having decided to opt for the Grand Lodge of India, we by the authority and under the sanction of the Grand Lodge of India vested in us for that purpose do hereby sanction and confirm that the said Lodge shall be constituted into a Lodge of Free and Accepted Masons under the title or denomination of Morland No. 25 on the rolls of the Grand Lodge of India.

By virtue of this warrant the said Lodge shall be deemed to be a foundation Lodge of the Grand Lodge of India.

The original Charter/Warrant of the said Lodge issued by the Grand Lodge of Scotland was dated 3rd May, 1875.

The said Lodge shall come under the jurisdiction of the Grand Lodge of India with effect from the date of issue of this Warrant.

The said Lodge shall be permitted to count its years of existence under its previous Charter/Warrant when making claims for Centenary Warrant, etc., under the Grand Lodge of India.

The said Lodge to meet at Goshamahal Baradari, Hyderabad on the Fourth Thursday of Every Month, empowering them in the said Lodge when duly congregated to make, pass and raise Freemasons according

to the ancient custom of the Craft in all Ages and Nations throughout the known World. And further that the Master, the Senior Warden and the Junior Warden for the time being shall continue to hold the said Lodge and until such time as another Master shall be regularly elected and installed, strictly charging that every member who shall be elected to preside over the said Lodge and who must previously have duly served as Warden in a warranted Lodge shall be installed in Ancient form and according to the laws of the Grand Lodge that he may thereby be fully invested with the dignities and powers of his office. And we do require you the said Master and Wardens, to take special care that all and every said Brethren are or have been regularly made Masons and that you and they and all the other members of the said Lodge do observe, perform and keep the Laws, Rules and Orders contained in the Book of Constitutions and all other, which may from time to time be made by our Grand Lodge or transmitted by us or our successors Grand Masters or by our Deputy Grand Master for the time being and we do enjoin you to make such By-Laws for the Government of your Lodge as shall to the majority of the members appear proper and necessary, the same not being contrary to or inconsistent with the General Laws and Regulations of the Craft, a copy whereof you are to transmit to us. And we do require you to cause all such By-Laws and Regulations and also all account of the proceedings in your Lodge to be entered in a Book to be kept for that purpose, and you are in no wise to omit to send to us our Successors Grand Masters or to our Deputy Grand Master for the time being at least once in every year a list of the members of your Lodge and the names and descriptions of all Masons initiated therein and Brethren who shall have joined the same with the fees and monies payable thereon. It being our will and intention that this our Warrant of Constitution shall continue in force so long only as you shall conform to the Laws and Regulations of our Grand Lodge and you the said Master and Wardens are further required as soon as conveniently may be to send us an Account in writing of what shall be done by virtue of these Presents.

**BY-LAWS
OF
LODGE MORLAND No. 25, GLI**

I. CONSTITUTION

1. **CHARTER:** Lodge "Morland" was duly constituted under a Dispensation granted by the Most Worshipful the Grand Master of All Scottish Freemasonry in India, Most Worshipful Brother Captain Henry Morland, on the 21st day of March A.D. 1875 and A.L. 5879, which Dispensation was subsequently confirmed under a Charter from the Grand Lodge of Scotland, dated the 3rd day of May A.D. 1875 and A.L. 5879 and the lodge was regularly opened on the 15th day of December of the same year and was numbered as 569 S.C. This Lodge having opted to the Grand Lodge of India was struck off the rolls of the Scottish Constitution and was entered on the rolls of the Grand Lodge of India on its consecration on 24th November 1961 and was numbered 25 G.L.I.
2. **OFFICERS:** The office bearers of the Lodge shall consist of Worshipful Master, Immediate Past Master, Senior Warden, Junior Warden, Chaplain, Treasurer, Secretary, Director of Ceremonies, Senior Deacon, Junior Deacon, Bible bearer, Gita bearer, Koran bearer, ZA bearer, Granth Saheb bearer, Sword Bearer, Assistant Secretary, Assistant Director of Ceremonies, Almoner, Organist, Inner Guard, Stewards and Tyler.
3. **REGULAR MEETING DAY:** The regular meeting of the Lodge shall be held on the fourth Thursday of every month except in the month of May.
4. **MEMBERS:** The Lodge shall consist of Resident, Absent, Honorary and Life Members.

5. **LIMITS OF JURISDICTION:** The word 'Station' shall be held to mean the Municipal limits of Greater Hyderabad and its adjoining Cantonment Areas.

II. CANDIDATES

6. **CANDIDATES:** Every candidate for initiation or Brother for joining or rejoining must be proposed and seconded by members in good standing at the Regular Meeting of the Lodge, and must be reported upon by the Standing Committee, before the ballot is proceeded with. All such candidates must be introduced to the Standing Committee.
7. **LIABILITY OF PROPOSER & SECONDER :** The proposer and seconder shall be both responsible for all fees and expenses incurred on account of such brother for a period of 12 months from initiation.
8. **REJECTED CANDIDATES:** A candidate who has been rejected by ballot, shall not be again eligible for proposal for twelve months.

III. BALLOT AND VOTING

9. **BALLOT:** The secrecy of the Ballot shall be held strictly inviolate, and when a Ballot taken either for initiation of a candidate or joining or rejoining of a Brother, unless a minimum of two thirds of the members present approve the proposal, the proposition of such candidature or Brother shall not be accepted.
10. **SECOND BALLOT:** The Worshipful Master, on a proposition duly seconded, may for the purpose of being assured that no mistake has occurred in the use of the black balls, cause a Second Ballot to be forthwith taken, which shall be final for all purposes.

11. VOTING WHEN DEBARRED: Any member whose subscription is in arrears for 3 months shall be debarred from balloting or voting on any question.
12. VOTING BY PROXY: No member shall be permitted to vote by proxy.

IV. LIFE, RESIDENT, ABSENT AND HONORARY MEMBERS

13. LIFE MEMBER: A resident member of the Lodge, who has been a subscribing member of one or more Lodge continuously for 20 years and has also attained the age of 55 years may become a Life Member of the Lodge on payment of 5 years' lumpsum subscription. This facility of becoming Life Member would also be available for one Lodge of the member's choice, if he has completed 20 years of continuous membership in more than one Lodge(s) and in such cases the Life Membership may be fixed at 50% more than that payable by other Life Members who have completed 20 continuous years in the same Lodge.

Moreover, the Life Membership subscription so paid will be exclusive of the Grand Lodge and Regional Grand Lodge dues which shall be payable in addition, at the rates as applicable from time to time. The subscription amount shall be as per By-Law No. 17

14. ABSENT MEMBER: A resident member may be placed as Absent Member when he leaves the station. No member leaving the station shall be treated as Absent Member until he informs the same in writing to the Secretary or announces it in the open Lodge. No office bearer shall be allowed to become an Absent Member during his term of office.
15. RETURN OF ABSENT MEMBERS : Any member who has been placed as Absent Member under By-Law No. 14 shall on his return to the station inform the same to the Secretary, who shall at once place him as Resident Member.

16. HONORARY MEMBER: An Honorary Member shall be elected by Ballot as per Rule 142 of the Book of Constitutions after notice of such election is placed in summons. However, consent of the brother on whom the Honorary Membership is to be conferred shall be received by the Lodge prior to balloting.

V. FEES AND SUBSCRIPTIONS

17. The following shall be payable to the Lodge by the members. The monthly subscription shall be **payable in advance**.

Initiation	Rs. 1500
Joining & Rejoining Fee	Rs. 800
Subscription per month (to be paid for 12 months in a year)	Rs. 150
Absent Member (per month)	Rs. 75

As part of the monthly subscription, the Lodge shall pay for and provide Grand Lodge Certificate to every Master Mason, Installed Master's Certificate to all the Installed Masters, aprons for the use of all members, dues to Grand Lodge and Regional Grand Lodge and subscription to GLI publication *The Square and Compasses*.

18. Should an Absent Member attend the Lodge or the Banquet, he shall be charged full subscription for the month.
19. Should the subscription of a member of the Lodge remain unpaid for 6 full months, the Secretary will send a Registered notice to him requesting settlement within 1 month from the date thereof.

If the payment is not received as stipulated, the Secretary would report to the standing Committee. The Committee in turn may recommend to the Lodge at the next regular meeting to exclude the said member under Rule 156 of the Book of Constitutions.

20. **CAPITAL FUND**: A sum of Rs. 2,00,000 (Rupees two lakhs only) shall always be maintained as capital fund. These funds shall be invested in Fixed/Term Deposits with the Banks and the interest accrued shall be added to the corpus.
21. In the event of any necessity arising for the withdrawal of funds out of the Capital Fund of the Lodge, instituted as per By Law No. 20, the notice of the same shall be brought in the summons. A majority of not less than three Fourths of the brethren in good standing present at the meeting shall be required to sanction the same in regular manner.
22. **BENEVOLENT FUND**: The benevolent fund will consist of the following :
- a. One half of initiations joining and rejoining fees.
 - b. Charitable collection in the meeting
 - c. Voluntary donations.
 - d. Interest accrued from General Fund deposits.
 - e. A maximum of 50% of the annual surplus of income over the expenditure.
 - f. Other contributions from General Fund as the Lodge may determine from time to time.

The Benevolent Fund shall be solely devoted for charitable purposes. A sum of Rs. 1,000 from this fund shall be held annually at the discretion of the Worshipful Master to meet the emergent cases of distress. The utilization of such funds by the Master shall be informed in the next regular meeting of the Lodge by the Worshipful Master.

23. **GENERAL FUND**: The amounts other than of Benevolent Fund under By Law No. 22 and Capital Fund under By-Law No. 20 shall constitute General Fund. Any amount in excess of Rs. 20,000 (Rupees Twenty Thousand only) of these funds in the Bank accounts shall be placed, either in short or long term fixed deposits as decided by the Standing Committee. Any fixed deposit of the General Fund may be

encashed after the same is approved in the open Lodge by the majority of brethren in good standing present at the meeting. All deposits made under By Laws Nos. 20 and 23 should be in scheduled Banks.

24. **SPECIAL BANQUET FEE**: It shall be within the powers of the Lodge to levy a special fee, on all members on any occasion on which a special banquet or other entertainment should be given, such as in the case of the reception of Regional Grand Lodge or Grand Lodge or other Masonic functions.

VI. PROPOSITIONS AND DISCUSSIONS

25. **PROPOSITIONS**: No proposition shall be entertained until it has been duly seconded; and when a motion has been duly made and seconded, the opinion of the Brethren present who may wish to speak thereon shall be taken before it is put to vote; but no vote shall be taken on any proposal until due notice has been given in the summons. This By-Law shall not have reference to the subject matter pertaining to correspondence brought up by the Secretary, subject to the discretionary powers of the Worshipful Master.
26. **MEMBERS RIGHT TO SPEAK**: No member shall be entitled to speak more than once upon any question before the Lodge, except strictly in explanation; but the member shall have the right of reply, after all the members, who may wish to do so, shall have addressed the Lodge.
27. **ADDRESSING LODGE**: Whenever a Brother may have occasion to speak in Lodge, he shall do so standing, in order, and shall address his remarks to the Worshipful Master in calm and decorous language.
28. **DISCUSSIONS**: To preserve the harmony of the Lodge, the Mater shall have the discretionary power, at any stage of a discussion, to stop its being proceeded with.

29. **RESOLUTION:** Any resolution passed in the open Lodge shall be binding on all the members of the Lodge.

VII. ELECTION & INSTALLATION

30. **ELECTION OF MASTER, TREASURER AND TYLER:** The Worshipful Master, Treasurer and Tyler shall be annually elected by ballot, at the Regular meeting in December.
31. **DATE OF INSTALLATION:** The Worshipful Master shall be duly installed at the regular meeting in January.

VIII. SECRETARY

32. **SECRETARY'S DUTIES:** The Secretary shall issue the summonses for, and record the Minutes of all Meetings and Committees, keep the Register of Members, and discharge such other duties as may be delegated to him by the Worshipful Master.

IX. TREASURER

33. **FUNDS WITH TREASURER:** The Treasurer shall collect all dues and fees and deposit all sums in excess of Rs. 200 (Rupees Two Hundred only) in his possession for over a week, in the Bank in the name of the Lodge with such Banks as may be decided by the Lodge. Provided that not more than a sum of Rs. 20,000/- (Rupees Twenty Thousand only) may be kept in a Bank. Funds in excess of Rs. 20,000/- shall be kept in Fixed/Term Deposits. All cheques must be signed by any two of the following viz., the Worshipful Master, the Secretary and the Treasurer.
34. **DUTIES OF THE TREASURER:** The Treasurer shall not pay any moneys of the Lodge, except the Statutory dues/levies and as otherwise provided for, without the direction of the Master and the brethren in the Lodge assembled.

X. TYLER

35. **TYLER'S DUTIES AND FEES:** The Tyler shall be paid an honorarium per meeting as decided by the Lodge from time to time. A subscribing member serving as Tyler shall be exempt from payment of monthly subscription and all other Lodge dues. He shall be responsible for the cleanliness of the Lodge and correct disposition of the Lodge furniture during the meeting.

XI. BUILDING COMMITTEE

36. The Lodge shall be represented in the Goshamahal Baradari Masonic Building Committee by five members consisting of Worshipful Master, Secretary and three members to be elected in the Open Lodge at the Installation meeting every year.

XII. AUDIT COMMITTEE

37. **AUDIT COMMITTEE:** An Audit Committee shall be elected by the Lodge at the Installation Meeting which shall consist of any three members with knowledge of accounts. The audit committee shall certify as per Rule No. 120 of the Book of Constitutions after due examination of the accounts of the lodge.

XIII. STANDING COMMITTEE

38. **STANDING COMMITTEE:** There shall be a committee, styled the Standing Committee of the Lodge, which shall consist of the Worshipful Master, all Past Masters, Past Wardens, the Senior and Junior Wardens, the Secretary, the Treasurer, the Senior and Junior Deacons, the Inner Guard and any seven of the said Standing Committee shall form a quorum.

39. **PRESIDENT OF STANDING COMMITTEE:** The Worshipful Master shall be the President, and the Immediate Past Master the Vice-President, of the Standing Committee, and in their absence The Senior Brother present shall preside.
40. **STANDING COMMITTEE MEETING:** The Secretary shall convene a meeting of the Standing Committee, when requested to do so by the Master.
41. **REFERENCE TO THE STANDING COMMITTEE:** The Worshipful Master is hereby authorised and empowered to refer to the Standing Committee, for consideration and report at any stage, any matter or proposition that may be brought before the Lodge, previous to putting the same to vote and on the Worshipful Master so referring the same, all discussions thereon in the Lodge shall immediately cease.
42. **NOTICE TO PROPOSER AND SECONDER:** When the Worshipful Master shall refer any motion to the Standing Committee, the Proposer and Secunder shall be invited to be present for the consideration of that particular question, and the Secretary shall send them notice of the time appointed for the Meeting.
43. **RULES FOR THE STANDING COMMITTEE:** The Rules for Lodge discussion shall also apply to discussions before the Standing Committee, the Presiding Officer whereof, for the time being, shall be entitled to the same respect as the Worshipful Master in the Lodge.
44. **STANDING COMMITTEE'S REPORT/ MINUTES:** At the regular meeting of the Lodge following that at which any reference has been made, the Standing Committee shall present its report/minutes and the Worshipful Master shall cause the same to be read in the open Lodge, after which its adoption or rejection shall be decided upon in the usual way on a motion duly made and seconded.

45. **STANDING COMMITTEE'S POWER:** The Standing Committee is hereby authorised and empowered to summon any member to give information on any matters referred to it by the Lodge.

XIV. GENERAL

46. **VISITOR:** Every Visitor must be well vouched for or required to produce his Grand Lodge Certificate and undergo an examination.

XV. LODGE PROPERTY

47. **LODGE PROPERTY:** Property of every description belonging to the Lodge shall be vested in the worshipful Master and the Wardens for the time being, in trust for the Lodge, except as may be otherwise provided for.
48. **INVENTORY:** An inventory of the whole of the Lodge property shall be entered into a book, which shall be verified by the Worshipful Master on his installation and shall be countersigned by himself and his Wardens. Such verification shall be reported in the immediate regular meeting after installation.
49. **JEWELS, & C:** The Warrant, Jewels and Working Tools belonging to the Lodge, shall be in charge of the Worshipful Master, or of such other Officers as he may appoint.

XVI. BY-LAWS

50. **BY-LAWS:** These By-Laws shall be read in the open Lodge at such time as the Worshipful Master may think proper or at least once a year, and each newly initiated or joining or re-joining brother shall be furnished with a copy.

51. ALTERATION OF BY-LAWS: The By-Laws or any portion of them shall not be altered without the sanction of a majority of the members present at a Regular Meeting of the Lodge, notice of the proposed alteration being given at the previous Regular Meeting and circulated with the Summons of the Regular Meeting at which it is to be considered and confirmed at the next Regular meeting and approved by R.W. the Regional Grand Master and M.W. the Grand Master.
