## ELECTION

3. The Annual Election of the Commander, Treasurer and Warder shall be held on the day of the Regular Meeting in the month of October.

4. The Commander Elect shall be installed at the next Regular Meeting held in the month of January.

## TREASURER

5. All payments exceeding Rs. 20/- shall ordinarily be paid by cheque only. The Lodge money shall be deposited in such Bank as the Lodge may from time to time direct. The Commander and Treasurer shall jointly operate the account.

## SCRIBE

6. The Scribe shall keep such books and make such entries as are prescribed under Rule 10 R.A.M. of the Book of Constitutions and shall also collect all dues and fees and transmit all monies to the Treasurer.

## WARDER

7. The Warder shall be paid for his attendance at each meeting when held and for the Superintending the preparation of the Lodge Rooms, a fee of Rs. 5/-.

It shall be the Warder's duty to keep the Warder's Book and to see that all the Brethren who enter the Lodge sign their names in it, to examine carefully all visitors and to see that the Brethren are properly clothed and the candidates are properly prepared.

## PERMANENT COMMITTEE

8. The Permanent Committee shall consist of Commander, Wardens, Subscribing P. Comdrs., Treasurer and Scribe. The Commander shall preside at such meetings and in his absence the next I.P. Commander and in the absence the next of any of these the Warden Senior in rank.

The Scribe shall not liable to pay any subscription.

ARREARS

11. Any Member whose dues shall remain unpaid for a period of six months shall receive notice

of the same from the Scribe and should they not be paid up within one month from the date of such notice the member shall be liable to be dealt with under Rule 118 of the Book of Constitutions for exclusion.

RESIGNATION

12. Any Brother wishing to resign shall intimate the same either by letter to the Scribe or in open Lodge.

EMERGENT MEETING

13. Should a Lodge of Emergency be summoned for the express purpose of Elevating any Brother or Brethren each such Brother shall pay an additional fee of Rs. 12/-.

ALTERATION OF BY-LAWS

It shall not be competent for the Brethren to abrogate, amend or alter these By-laws unless the

abrogation shall have been duly proposed and passed at one Regular Meeting, after insertion in the summons and read and confirmed at the next Regular Meeting of the Lodge. The change shall not become effective until subsequently approved by the D. G. M., and The Grand Master's Royal Ark Council.
