

ORIGINAL BY LAWS

PROPOSED BYLAWS

EXPLANATORY

PREAMBLE

(new)

We, The Worshipful Master, Wardens and Brethren of Lodge Ernakulam No. 243 are now bringing into force the Bye-Laws of this Lodge, with a view to preserving peace, unity and harmony, therefore, thought it proper to establish and subscribe to the following Rules and Regulations.



NOTE

The lodge is facing difficulties in operating its bank accounts in the absence of a PAN card. This is on account of the lodge not being able to show an adequate proof of address. The Lodge had many years ago already approved that the Secretariat of the lodge would be at Sreepatham Krishnaswamy Road, Cochin 682 035. It is felt by incorporating this preamble in the bylaws it may facilitate the granting of a PAN Card for the lodge.



1 MEMBERS

1) Lodge May have three classes of members namely:

i) Resident Members:

ii) Life Members: and

iii) Honorary Members

2) Any member who resides permanently within the District of Ernakulam will be deemed a Resident Member and will pay the monthly Lodge subscription accordingly.

3) A member who was a subscribing member for 20 years in the Lodge and had also attained the age of 55 years can, by application in writing and on payment of a lumpsum equal to 5 years subscription could become a Life Member of the Lodge.

4) Honorary Members are those elected as such, for meritorious services rendered to Freemasonry in general or to the Lodge in particular as provided in Rule 142 of the Book of Constitution.

Honorary Members shall pay no


2) Any member who resides permanently within the District of Ernakulam will be deemed a Resident Member and will pay the monthly Lodge subscription accordingly.

3) Honorary Members are those elected as such, for meritorious services rendered to Freemasonry in general or to the Lodge in particular as provided in Rule 142 of the Book of Constitution.

Honorary Members shall pay no admission fees or contribution of any kind, but shall not be eligible to vote or hold any office.

4) All members will communicate promptly their change of address to the Secretary.

The class of member as Life Member is sought to be removed as in the event that a member seeks to exercise that option, the lodge would be put to financial difficulty as the lodge would then be liable to pay the dues to the GLI/RGL. It may also be noted that life membership is a facility that can be granted by a lodge at its discretion. (See Rule 142 A of the B of C)




**VI. STANDING
COMMITTEE**

15) A standing Committee for general purposes shall be constituted at the Installation Meeting, consisting of the Master, Immediate Past Master, the two Wardens, all the Past Masters of and in the Lodge under the Indian Constitution or recognised Constitutions, Treasurer, Secretary and two elected members who do not hold any regular office in the Lodge.

**VI. STANDING
COMMITTEE**

15) A standing Committee for general purposes shall be constituted at the Installation Meeting, consisting of the Master, Immediate Past Master, the two Wardens, all the Past Masters of the Lodge, Treasurer, Secretary and two elected members..

The standing committee is becoming too unwieldy hence those past masters not of this lodge are sought to be excluded. As per practice the deacons are elected as members of the standing committee but they are officers of the lodge which is in conflict with the bylaws hence the change.



III. DUES AND FEES

1. Fees and subscription payable to the Lodge will be paid in advance as follows:


- a) An annual Subscription of Rs. 2000/- and the dues payable to the Grand Lodge and the Regional Grand Lodge.
- b) Fee for Initiation shall be Rs. 1500/-. This is inclusive of all fees payable by the Lodge to the Grand Lodge and Regional Grand Lodge.
- c) Fee for joining or re-joining from the Indian Constitution shall be Rs. 1000/-
- d) Fee for joining from a recognised constitution shall be Rs. 1000/-

III. DUES AND FEES

1. Fees and subscription payable to the Lodge will be paid in advance as follows:

- a) An annual Subscription of Rs. 2000/- and the dues payable to the Grand Lodge and the Regional Grand Lodge.
- b) Fee for Initiation shall be Rs. 1500/-. This is inclusive of all fees payable by the Lodge to the Grand Lodge and Regional Grand Lodge.
- c) Fee for joining or re-joining from the Indian Constitution shall be Rs. 1000/-
- d) Fee for joining from a recognised constitution shall be Rs. 1000/-
- e) After approval in open lodge, the lodge may levy such other fees at such rate as may be specified by the lodge on all its members. The lodge may also exempt any member or class of members from the levy of such fee.

New bylaw 6 (E) is proposed to be introduced



VIII. DUTIES OF TREASURER

- i) The Treasurer shall collect all moneys payable to the Lodge and deposit them in a Bank, approved by the Lodge and in the name of the Lodge. He shall make payments for current routine expenses with the permission of the Master.
- ii) The Treasurer shall make payment of petty contingent expenses, for which purpose he shall keep an imprest cash of Rs 50/- only.

VIII. DUTIES OF TREASURER

- i) The Treasurer shall collect all moneys payable to the Lodge and deposit them in a Bank, approved by the Lodge and in the name of the Lodge. He shall make payments for current routine expenses with the permission of the Master.
- ii) The Treasurer shall make payment of petty contingent expenses, for which purpose he shall keep an imprest cash of Rs 5000/- only.

Although for many years now the Treasurer has never held an imprest amount. It is felt that the sum of Rs 50 provided earlier was too meager and to avoid any contingency in future the amount needs to be enhanced to Rs 5000.
