

## BYE-LAWS OF LODGE THIRUNAL

1. BY-LAWS Name of the Lodge shall be LODGE 'THIRUNAL' No. 179 The Meetings of the Lodge will be held at Freemasons' Hall, No. 19, Primrose Road, Bengaluru - 560025.

### MEMBERS

2. The Lodge shall consist of Resident, NonResident and Life Members.

2.1 (a) Resident members are those residing in the limits of BBMP Bengaluru or City Corporation.

(b) Resident members who have shifted their residence out of Bengaluru due to personal or professional avocations for a period of not less than 6 months may on request be admitted as Non-Resident member.

(c) Life members are those members who have attained the age of 55 years and have been continuously subscribing members of the Lodge for 20 years and who have after 1-1-1995 paid a one time lumpsum subscription equivalent to normal subscription of ten years as currently applicable to Resident members.

2.2 Subject to Rule 142 of the Book of Constitution the Lodge may elect Honorary members.

### MEETINGS

3. (a) The Regular Meeting of the Lodge shall be held on the third Saturday of every month at such hour as the Worshipful Master may fix.

(b) (i) The Master of the Lodge shall be elected annually by ballot at the Regular meeting in June (vide Rule 87 of B of C).

(ii) The Treasurer shall be elected annually at the Regular Election Meeting in June.

(iii) The Tyler shall be elected annually at the Regular Election Meeting in June (vide Rule 93 of the B of C). The Tyler, if a serving brother, shall be chosen at the Regular Meeting in June.

(c) The Installation of the Master shall take place at the Regular Meeting of the Lodge in July. Succeeding the Election Meeting in June.

### OFFICERS

4. (a) The Regular Officers of the Lodge shall be the Master. The immediate Past Master, Senior Warden, Junior Warden, Treasurer, Secretary, Senior Deacon, Junior Deacon, Inner. Guard, Tyler (vide Rule 86 of B of C).

- (b) The master may appoint as additional officers a Chaplain, a Director of Ceremonies, an Assistant Secretary, Assistant Director of ceremonies, an Almoner, Bearers of Volume of Sacred Laws, a Sword Bearer, an Organist, and Stewards and no others (vide Rule 86 of B of C).
- (c) The master may appoint a Brother who is holding a Regular Office to one additional office also (vide Rule 86 of B of C).

#### **PERMANENT COMMITTEE**

- 5. (a) The Permanent Committee shall consist of Wor. Master (who will be Ex. Officio Presidento, all Past Masters in and of the Lodge, the Senior and Junior Wardens, Treasurer and Secretary and two Members to be appointed by Lodge at the Installation Meeting (The Tyler will be in attendance)
- (b) (i) The Permanent Committee shall meet at No.19, Primrose Road, Bengaluru - 560025, at 5.30 p.m, on the Third Saturday or on any day and time the Worshipful Master may order.
- (ii) The quorum for the Permanent Committee shall be four.
- (c) The Permanent Committee shall check the Treasurer's Accounts, inspect and report on the Lodge property, consider and report on the proposals for membership of the Lodge and to transact any other business brought forward; (Vide Rule 129 of B of C).

#### **SECRETARY**

- 6. (a) The Secretary shall conduct the General Correspondence, Record the Minutes, Issue Summons and make due returns to Grand Lodge and Regional Grand Lodge. He shall also be the Ex-officio Secretary of the Permanent Committee. The Secretary shall be exempt from paying the Lodge Subscription. (Vide Rule 86 of B of C).
- (b) The Secretary shall take note of members coming within the provision of By-law No. 10.3(b) and Rule 124 & 156 of B of C and report to the Lodge and take necessary steps to enforce the above provision.
- (c) The Secretary shall be in-charge of all Lodge records and books other than account books which are maintained by the Treasurer.

#### **TREASURER**

- 7. (a) The Treasurer shall collect all fees and dues and shall issue receipts for the same. He shall deposit them in any of the Nationalised or Scheduled Bank or both, approved in the Open Lodge. (Amended and approved on 4-1 1985).
- (b) The Lodge by resolution may also invest its funds in Government and other

recognised securities. The Lodge by resolution, may sell or borrow against such securities.

- (c) All financial transactions of Lodge shall be carried out by the Treasurer, Worshipful Master and the Secretary, The Treasurer and any one of the other two officers, namely, the Wor. Master and the Secretary shall sign at a time.
- (d) Cheques shall ordinarily pay all payments exceeding Rs. 100/- only.
- (e) The Treasurer shall intimate to the Secretary all cases of arrears falling under By-laws No. 10.3(b) and Rule 124 and 156 of B of C.
- (f) The Treasurer is also authorised to correspond with members regarding collection of fees and other dues.
- (g) All receipts to be given and routed through Treasurer so that they will be appropriately accounted and receipts issued.
- (h) The Treasurer will maintain all the account books, cheque books, pass books etc. related to the Treasurer's duties

#### **TYLER**

- 8. (a) The Tyler shall be exempt from Lodge Subscription. (Vide Rule 86 of B of C).
- (b) when the Tyler is a serving brother he shall be paid an honorarium of Rs. 7-50 per meeting.

#### **FEES**

- 9. (a) For Initiation, passing and raising Rs. 3000
- (b) For joining from another Constitution duly recognised by Grand Lodge of India Rs.1000/
- (c) For joining from a Lodge under Grand Lodge of India Rs. 1000/
- (d) For rejoining :Rs.1000/ (Amended and approved on 29-11-1994)

#### **SUBSCRIPTION**

- 10. (c) Rs.40/- month. In addition, all dues of the Grand Lodge of India and of the Regional Lodge of India and of the Regional Grand Lodge of Southern India payable by the Lodge (annually) for its members, to be recovered from each member at actuals as charged by the G.L.I. and by the Regional Grand Lodge of S.I. (Amended and approved on 21-11-1992)
- (d) The RGL and GLI dues as applicable will be paid by all members in addition to their

annual subscription.

- 10.1 (a) The annual subscription of Rs. 2100/- due to be paid by Resident Members in advance during the month of July every year.
- (b) If a Resident member is initiated or joins during the period January to June the subscription payable will be Rs. 1050/-
- (c) The annual subscription to Non Resident members will be Rs. 1050. The amount will due to be paid by a Non-Resident Member irrespective of the date/month of Initiation/Joining

- 10.2 (a) The Lodge shall take a collection for the Benevolent Fund at every Meeting.
- (b) The Benevolent Fund shall be utilised to make contributions to Masonic Charities and to aid a distressed brother or the dependents of a deceased brother. The merits of each case shall be investigated by the Permanent Committee.

- 10.3 (a) In circumstances of emergency, the worshipful Master may accord relief upto Rs. 2000/- and the matter when reported to the Lodge at the next Regular Meeting, the Worshipful Master shall be reimbursed from the Lodge Benevolent Fund.
- (b) If any member allows his subscription to remain in arrears for 12 months, Such defaulting members shall be liable to be cessated under Rule 124 of Book of Constitutions, after due notice is served by email or Registered post.
- (c) In case a member stands to be cessated owing to non-payment of subscription the proposer & seconder of a candidate to be responsible, equally for subscription due to the Lodge until the date of cessation

#### BALLOT

11. (a) All candidates for Initiation, Joining or Rejoining must be proposed at a Regular Meeting according to Rule 134 and 137 of the B of C.
- (b) Every application for Initiation or Joining shall be placed by the Secretary before the Permanent Committee for due enquiry and report. Any information by a Brother regarding the character or qualification of a candidate shall be treated with strict confidence.
- (c) No person shall be made a Mason or accepted as member of the Lodge, unless if on ballot for initiation/joining/rejoining, simple majority of members present and voting in the Lodge approve the proposals for such Candidate.

- (d) A collective ballot for two or more candidates for initiation or joining may be taken with approval of the Lodge. Should there however be even one black ball, each candidate should be balloted for individually as per article 11 (c )
- (e) The WM will not ballot when the ballot box is taken around. WM will take a casting vote if votes are equal
- (f) Honorary Member - Election - Rule of 142 B of C. The motion for election of an honorary member shall be voted on by ballot and declared carried unless 3 or more black balls appear against it.
- (g) No rejected candidate can be proposed again until a period of six months has elapsed from the date of the Ballot. (Vide Rule 139 of the B of C).

#### **LODGE COLOURS**

- 12. The colour of the Regalia worn shall be Light Blue.

#### **PROPOSALS**

- 13. (a) No motion shall be put to the Lodge assembled unless duly proposed by one member and seconded by another.
- (b) An amendment to any proposition may be made duly proposed and seconded. Amendments shall be put to the vote first, if negatives the original proposition shall then be put to the vote, but if the amendment is carried, the original proposition shall be decided to be lost.
- (c) No proposition of importance shall be brought forward for consideration, unless notice thereof, has been given, at the previous Regular Meeting or in writing to the Secretary, well in advance and in time to be circulated with the summonses of the meeting.

#### **BY-LAWS**

- 14. (a) These By-laws shall be printed at the expense of the Lodge and a copy presented to every brother. Every Member on his initiation or joining shall receive a copy of the By-laws. His acceptance shall be deemed to be a declaration of his submission to them.
- (b) These By-laws shall be read in open Lodge at a Regular Meeting at least once a year.
- (c) In any case, for which the foregoing By-laws do not provide, the laws and Regulations contained in the Book of Constitutions of the Grand Lodge of India shall be binding on all concerned.
