BE IT KNOWN that Our Excellent Companions Thomas Key, Z., John Cameron, H., James Oliphant, J., D.S. Young, George F.C. Fitzgerald, John H. Gunthorpe, George F. Hampton, George H. Milness, and James A. Gunthorpe, having made known to our Supreme Grand Chapter their desire of holding a Chapter of our Order for the cultivation of this Grand and Universal Science, in Hopes thereby the more to extend their Aid to and promote the Happiness of all our Brethren and link Mankind together by indissoluble Bonds of Friendship, Peace and Harmony, and that Our Grand Chapter having taken their petition into consideration and finding it concordant with Our Grand System of Universal Benevolence. WE DO HEREBY, with the Consent of our said Grand Chapter, grant unto the said Companions this our Chapter of Constitution to be held with and attached to the Warrant of the Lodge No. 628, called SAINT JOHN'S LODGE, with full Power for Them, their Companions and Successors, to open and hold a Chapter of

our Order at Secunderabad, Presidency of Madras, or at such other Place and at such Time as our Said Companions and their Successors shall, with the Consent of US and Our Successors, Grand Officers for the Time being, think meet, The first Chapter to be opened on the 22nd day December 1853 now next ensuing, by the Title of THE SAINT JOHN'S CHAPTER with such Privileges, Powers and Immunities as do of Right belong to regular established Chapters and Companions of Our Said Most Excellent Grand and Royal Chapter.

Given at London under Our Hands and the Seal of Our Grand and Royal Chapter, this 7th Day of November A.L. 5838, A.D. 1838.

## THE SUPREME GRAND CHAPTER OF ROYAL ARCH MASONS OF INDIA.

TO ALL AND EVERY OUR MOST EXCELLENT, AND  
LOVING COMPANIONS.

KNOW YE That the Chapter St. John's No. 434 on the roll of the Supreme Grand Chapter of England having opted for the Supreme Grand Chapter of India, we, by the authority and under the sanction of the SUPREME GRAND CHAPTER OF INDIA vested in us for that purpose do hereby sanction and confirm that the said Chapter shall be constituted a Chapter of our Order under the title and denomination of Chapter St. John's No. 1 on the rolls of the Supreme Grand Chapter of India.

By virtue of this Charter the said Chapter shall be deemed to be a FOUNDER CHAPTER of the Supreme Grand Chapter of India.

The original Chapter/Warrant of the said Chapter issued by the Supreme Grand Chapter of England was dated 7th November, 1838.

The said Chapter shall count its years of existence under its previous Charter/Warrant when making claims for Centenary Jewel etc., under the Supreme Grand Chapter of India.

The said Chapter shall meet at St. John's Hall, Secunderabad on the Second Tuesday in February, April, June, August, October and December with such privileges, powers and immunities as do of right belong to regular, established Chaptres and Companions of our said Most Excellent Order, subject never-the-less to the General Laws and Ordinances already, or to be hereafter, enacted by our Most Ex. Grand & Royal Chapter.

Notwithstanding anything in these Regulations and pending the formation of the necessary provisions to cover the Mark and other Degrees, in due course, the said Chapter shall be permitted to continue to work those degrees only which formerly were permitted under the Regulations then governing their working.

Given under the seal of our Grand & Royal Chapter this Twenty Second day of November, 1963 corresponding to 1st Agrahayana, 1885 Saka Era.

# Royal Arch Chapter St. John's No. 1 Secunderabad

**Note:** The following by-laws are intended to provide only for such matters as are not settled by the General Regulations of the Supreme Grand Chapter of Royal Arch Masons of India.

## BY - LAWS

(AS AMENDED UPTO JANUARY 2006)

### MEETINGS

1. The Regular Convocation of the Chapter shall be held at St. John's Hall, Secunderabad - 500 026 on the SECOND Tuesday in the months of February, May, August and November.
2. Emergency Convocations can be held only in accordance with Regulation No. 63 of the of Royal Arch Masons of India General Regulations of the Supreme Grand Chapter.
3. The Chapter shall consist of
  - (a) Subscribing
  - (b) Absentee and
  - (c) Honorary Members.

Companions of Distinction may be elected as Honorary Members of the Chapter for which purpose the provisions of Rule 142 of the Book of Constitutions (Craft) shall apply.

An Honorary Member pays no fees or subscription and will not be entitled to vote on any proposition or election or hold office in the Chapter. He shall be presented with a copy of the By-laws when elected.

### ELECTION

4. The three Principals and Treasurer shall be elected by ballot at the regular Convocation in November, while the Janitor, subject to the provisions of the Regulation No.52 para 5, of Royal Arch Masons of India General Regulations of the Supreme Grand Chapter, shall be elected by show of hands.

In addition to the above officers, Two Scribes, a Director of Ceremonies, a Principal Sojourner, two Assistant Sojourners, an Assistant Director of Ceremonies, an Assistant Scribe E, an Organist and Stewards may be elected or appointed as the case may be.

The Installation of the Principals Elect and the investiture of Offices shall take place at the Regular Convocation in February of the following year.

Under Regulation No. 52, Para 3, Royal Arch Masons of India General Regulations of the Supreme Grand Chapter, the Chapter may, on the day of Election, give the authority to the Principals Elect to appoint the rest of the Officers.

### ADMISSION

5. The admission of candidates for Exaltation and Joining shall be regulated by the provisions of Regulations No. 69 to No. 73, Royal Arch Masons of India General Regulations of the Supreme Grand Chapter.

### FEES & SUBSCRIPTIONS

6. The following are the fees and subscriptions of the Chapter, strictly payable in advance in all cases:

Joining from a Chapter under a foreign Constitution	Rs. 1,000
Joining from a Chapter under Indian Constitution	Rs. 750
Subscription per Annum	Rs. 600
Plus SGCI and RGCSI dues as per actual

General Fund	Rs. 200
Stewards' Fund (Dinner for 3 convocations)	Rs. 300
Charity Fund	Rs. 100

AND: SGCI and RGCSI dues as per actual

7. The Scribe E shall be exempted from payment of Subscriptions to the Chapter.
8. The Janitor, if a serving member, shall be paid such remuneration as may be fixed by the Chapter from time to time.
9. Any candidate on whose account Emergency Convocation is held, may, at the discretion of the First Principal be required to pay all or any expenses incurred for such convocation.
10. Any candidate or member on whose account a Dispensation is obtained, may, at the discretion of the First Principal be called upon to pay the expenses incurred for such Dispensation.

## ARREARS

11. A member whose subscription remains un paid for six months, shall not be permitted to vote or submit any proposition to the Chapter or be elected to any office, nor will be allowed to propose or second candidates.
12. If a member be in arrears with his subscription to the Chapter for one year, the Scribe E shall advise him of the amount due by Registered Post, and if the full amount be not paid within thirty days from the date, he shall be excluded in accordance to Regulation No. 75, Royal Arch Masons of India General Regulations of the Supreme Grand Chapter.

## RESIGNATIONS

13. A member wishing to resign, must inform the Scribe E accordingly in writing, or tender such resignation in open Convocation of the Chapter in accordance with Rule 158 of Book of Constitutions (Craft). He shall be given a certificate under Regulation No. 74, Royal Arch Masons of India General Regulations of the Supreme Grand Chapter, provided he pays up all his dues.

## PROPERTY

14. The property of the Chapter shall be considered as vested in the Three Principals for the time being in trust for the Chapter, and an inventory of the same shall be entered in the Property Register and be signed by the Three Principals as soon as after their Installation as possible. This fact must be recorded in the minutes of the next regular Convocation.

## DUTIES OF OFFICERS

15. The Scribe E shall duly record the minutes of all the Convocations of the Chapter and of the Committees under the direction of the 1st Principal. He will issue all Summonses a clear seven days before each Convocation or Meeting and conduct the correspondence of the Chapter under the direction of the First Principal.
16. The Treasurer will collect all moneys due to the Chapter, make necessary disbursements when duly passed for payment by the First Principal in charge of the Chapter, and is responsible for the safe custody of the Chapter funds. He will pay all sums exceeding Rs.500 by cheque and pay all monies received by him into the bank soon thereafter, retaining Rs.250 only for emergencies. He will balance the Chapter Accounts and submit them for audit to the Audit Committee. In the absence of the Treasurer, monies will be collected by Scribe E who will pay over the same to the Treasurer soon thereafter.
17. The Janitor shall be responsible for the safe custody of the Regalia and equipment of the Chapter, and maintain them in proper condition. He shall prepare the Chapter Rooms for Convocations and in every respect discharge the duties of his office conscientiously and dutifully.

## COMMITTEES

### a. *Permanent Committee*

18. There will be a Permanent Committee of the Chapter consisting of the Three Principals, Scribes E and N, Treasurer, Principal Sojourner and all past First Principals in the Chapter. The First Principal or in his absence the senior First Principal present shall preside.

The Committee will consider all matters referred to it by the Chapter and the Accounts before the Installation Convocation in February. Three will form a quorum.

### b. *Audit Committee*

19. The Audit Committee shall consist of two members of the Chapter who shall be elected annually at the Installation Convocation in February. The accounts shall be made upto 31st December in each year and shall be presented to the Chapter, duly audited at the Installation Convocation in February. A copy of the audited accounts shall be sent to all the members with summons convening the Installation Convocation.
20. The First Principal, may, at his discretion, appoint special Committee(s) for the consideration of special subject(s). Such Committee(s) shall consist of at least three members besides the Three Principals, and the Scribe E of the Chapter. The First Principal or in his absence the Senior Member present shall preside. Three will form a quorum.

## FUNDS

21. The moneys of the Chapter shall be held under the following distinct heads:
  - a. *General Fund*: Subscriptions paid by the members of the Chapter as well as other moneys, not otherwise specifically allotted shall be credited to the General Fund. Payments from this Fund, except for routine purposes, or as have been duly authorized by the Chapter can be made only by resolutions of the Chapter, of which due notice shall have been given in the Summons for the regular or emergency Convocation.

- b. *The Charity Fund*: The Charity fund shall consist of Charity collections made at the Chapter Convocations, voluntary contributions to the Fund and such other moneys as may be regularly voted by the Chapter, from time to time, from its General Fund. Moneys from this Fund shall be devoted solely to charity but no expenditure be incurred without the prior sanction of the Chapter.

## ACCOUNTS

22. Accounts should be opened in the name of the Chapter in Bank(s) approved by the Chapter.
23. The accounts shall be operated jointly by the Treasurer with either the First Principal or the Scribe E of the year.

## BY-LAWS

24. Each candidate at his Exaltation or Companion on joining the Chapter shall be presented with a copy of the By-laws of the Chapter.
25. These By-laws shall be read in the open Chapter at least once in every year.
26. Except as otherwise required by Rule 111 of Book of Constitutions (Craft), amendment of these By-laws or any of them may be made only in the following manner:
- a. Notice of motion in writing stating the precise amendment(s) proposed shall be given in open Chapter at Regular Convocation.
- b. The motion shall be set out in the summons for the next regular Convocation or for an Emergency Convocation summoned for the purpose, and shall at such convocation be put to the Chapter.

- c. A resolution for amendment, of which notice shall be carried, if a majority of the members voting, shall vote in favour of it, but it shall not be effective until approved by the Grand Superintendent and by the First Principal.

The above By-laws were unanimously passed at the Regular Convocation of the Chapter held on Tuesday, 8th December, 1964 and were duly confirmed at the Regular Convocation held on Tuesday, the 9th February, 1965.
