

Out of the monthly subscription of Rs.75 paid by Non-Resident and Resident Absentee Members, a sum of Rs.25 shall be credited to the Benevolent Fund. Other than this, the Lodge can transfer funds to the Benevolent Fund / Stewards' Fund by resolution of the Lodge.		13. Monthly subscription paid by the Members as well as other monies not otherwise specifically allocated shall be credited to the General Fund. Payment from the Fund except for routine purposes can be made only by resolution of the Lodge.
