Bye-Law No. 2 : DAY AND PLACE OF MEETINGS : 2. The Regular Meetings of the Lodge shall be held at "Kumbakonam Freemasons' Trust Hall, at Pulianchery, near Kumbakonam, on the Second Saturday of every month except the months of April, May and June and at such hour as may be directed by the Master from time to time. Bye-law No. 38 : ELECTION AND INSTALLATION : 38. The Master and the Treasurer shall be elected by ballot and the Tyler chosen at the Regular Meeting in December. The Master Elect shall be installed in the Regular Meeting in January. The Treasurer elected and Tyler chosen shall be invested at the Installation Meeting in January and if one or both of them were to be absent at the Installation Meeting they shall be invested at the next meeting in which they be present.




