

Membership and Subscription Every Companion shall pay an annual subscription of Rs.600/- The Subscription will be paid in advance.</p> <p>(a) If any Companion is in arrears of Subscription to this Chapter for 6 months, the Scribe 'E' shall advise him of the amount due by him registered post and if the full amount be not paid within 30 days from the date, he shall be excluded in accordance with Regulation 75 of R.A. Regulation.</p> <p>If the subscription of the Companion to his Chapter remains paid for one full year at the expiration of the period he shall cease to be a member of the Chapter and the fact shall be reported to the Chapter at its Regular Convocation and recorded in the minutes.</p> <p>In either case, he shall become a member again only by payment of arrears followed by regular proposition and ballot according to Regulation 70 of R.A. Regulation.</p> <p>(b) The Janitor, if he is a serving Companion shall be paid a remuneration of Rs.150 for each Convocation of the Chapter. He shall be exempted from payment of subscription.</p>	<p>6. Membership and Subscription Every Companion shall pay an annual subscription of Rs.600/- The Subscription will be paid in advance.</p> <p>The Annual Dues payable to the Supreme Grand Chapter of India and the Regional Grand Chapter of Southern India, shall be in addition to the above subscription, at actuals.</p> <p>The Contribution to the Stewards Fund shall be in addition to the above, the quantum, of which shall be fixed by the permanent committee from time to time, subject to a maximum of Rs.400/-</p> <p>(a) If any Companion is in arrears of subscription to this chapter for 6 months, the Scribe 'E' shall advise him of the amount due by him registered post and if the full amount be not paid within 30 days from the date, he shall be excluded in accordance with Regulation 75 of R.A. Regulation.</p> <p>If the subscription of the Companion to his chapter remains unpaid for two full years at the expiration of the period he shall cease to be a member of the Chapter and the fact shall be reported to the Chapter at its Regular Convocation and recorded in the minutes.</p> <p>In either case, he shall become a member again only by payment of arrears followed by regular proposition and ballot according to Regulation 70 of R.A. Regulation.</p> <p>(b) The Janitor, if he is a serving companion shall be paid a remuneration of Rs.250/- for each convocation of the Chapter. He shall be exempted from payment of subscription.</p>
