

b) Non-Resident Members Rs. 30.00

Out of the quarterly subscription of Rs.75/- paid by the Resident Member a sum of Rs.45/- shall however, be credited to the "Stewards Fund" to cover the cost of his Dinner and Rs.30/- towards General Fund.

Resident absent members (Rs) who are invalid infirm disabled and/or in financial distress and unable to attend the convocation of the Chapter shall on application be charged monthly subscription of Rs.10/- instead of Fee prescribed under Bye-law No.6 of the Chapter, they shall, however, be charged prescribed fee of Resident Members for the month/months in which they attend the convocation of the Chapter.

Resident absent members (Rs) who are invalid infirm disabled and/or in financial distress and unable to attend the convocation of the chapter shall on application be charged monthly subscription of Rs.15/- instead of Fee prescribed under Bye-law No.6 of the Chapter they shall, however, be charged prescribed Fee of Resident members for the month/months in which they attend the convocation of the Chapter.


The above amendments were regularly Proposed and Seconded in open Chapter at a Regular Convocation held on the Dec. 22, 2001


