BY-LAWS OF LODGE VIVEKANANDA

No. 254
KANYAKUMARI

Members:

1. The Lodge shall comprise of-
 - (a) Subscribing members.
 - (b) Honorary members.

Honorary members are those elected, as such, for services rendered to Masonry in general or to this Lodge in particular. (R 142 Book of Constitutions).

Meetings:

2. The regular meetings of the Lodge shall be held at Vivekananda Puram, Kanyakumari on the second Saturday of every English calendar month, at such hour as the Master decides.
3. Summons convening the regular meetings shall be issued at least seven days

before the meetings. Emergency meetings, however, may be convened at shorter notice.

Fees and dues:

4. The fees and subscriptions shall be as follows and payable in advance.

	Rs.
(a) Subscription for membership for an year (Rs. 200 + Rs. 30 (Steward Fund)	150.00
but those admitted in the second half year need pay only	80.00
(The official year of the Lodge shall be the English calender year).	
(b) Initiation	750.00
(c) Joining or rejoining	100.00
(d) Joining from a foreign constitution	200.00

5. The expenses of any Emergency meeting and the Dispensation fees, if any, shall be defrayed by the Brother or Brethren at whose instance the meeting is held.

Admission & Retirement of Members:

6. No candidate for Initiation or joining shall be accepted, if two black balls appear in

a ballot. No such candidate shall again be proposed until six months have elapsed.

7. A member whose subscription is unpaid for one year shall be debarred from exercising the rights of voting, proposing or seconding candidates and being appointed or elected to any office. He is also liable to be excluded, under rule 156 of the B of C.

8. One who has ceased to be a member shall not be readmitted unless he has paid all his dues and subjected to a fresh ballot.

Elections, etc.

9. The Master and Treasurer shall be elected by ballot and Tyler elected (R 87 92 A & 93 B of C) at the Regular Meeting in January. The Master-elect shall be installed at the Regular Meeting in February.

Standing Committee:

10. An Annual Committee shall be constituted at the Installation Meeting, consisting of the Master, IPM, the two wardens, Treasurer, Secretary and two members who do not hold any regular office and elected by the Lodge.

The duties of the Committee shall be-

- (a) To scrutinise the monthly financial statement.
- (b) To enquire into the eligibility of every candidate proposed for admission.
- (c) To take an inventory of the Lodge property and report on its condition.
- (d) To present the annual report at the Installation Meeting.
- (e) To consider and suggest any matter tending to promote the welfare of the Lodge.

Audit Committee:

11. A Committee of two (who are not members of the standing Committee) shall be appointed by the Lodge at the December meeting for auditing the accounts of the year. The audited statement shall ~~from~~ part of the Annual Report.

12. The control of the property of the Lodge shall be as provided in R 119 B of C.

13. The Treasurer shall collect subscription and other dues and shall issue receipts therefor. He shall be in charge of all moneys and make payments for current routine expenses

with the permission of the Master. All moneys shall be deposited in a Bank approved by the Lodge, and in the name of the Lodge. The Treasurer is authorised to operate on the accounts. He shall submit financial statements at the Regular Meetings of the Lodge.

14. The disbursement of any amount exceeding Rs. 50/-, otherwise than for routine expenses shall be paid by cheque and requires the previous sanction of the Lodge, under notice.

15. The Secretary shall be in charge of the Lodge records and books other than the account books maintained by the Treasurer. He shall conduct all general business and correspondence of the Lodge. He shall be Ex-officio member and convener of all Committees appointed by the Lodge.

16. No alteration or addition to these bye-laws shall be made except by a motion carried at a Regular Meeting, after due notice and confirmed at the next Regular Meeting and approved by the R. W. Regional Grand Master and the M.W. Grand Master.
