


Existing By-Laws	Proposed amendments to By-Laws
By-Laws No 3 The Regular meetings of the Lodge shall be held at the Poppy's Hotel, Thirumuruganpoondi, Tirupur, place amended to Hotel MKM rich, and subsequently to Freemasons Hall, Sundamedu Tirupur on the Last Tuesdays of all the month in the year January to December or at such hour as the Master, from time to time direct. Summons convening the Regular Meetings of the Lodge shall be issued by secretary at least seven days previous to such meetings. The summons shall specify the place and hour of the meetings.
