The Treasurer and Tyler shall be elected and chosen respectively each year at the Regular Meeting of the Lodge in November and invested as such at the Installation Meeting in January	The Master shall be elected annually at the Regular Election Meeting of the Lodge in October and shall be Installed at the next Regular Installation Meeting in January. iii. Such annual dues payable to the Regional Grand Mark Lodge of Southern India as may be fixed from time to time. The above subscriptions shall be payable in advance each year in January.

Candidate for Advancement, Joining/Re-joining at any part of the year shall pay the full annual subscription together with the admission fees for Advancement, Joining/Re-joining as the case may be. Honorary Members are not liable to pay any fees.

iii. Such annual dues payable to the Regional Grand Mark Lodge of Southern India as may be fixed from time to time. Above subscriptions shall be payable in advance in January each year.

Candidate for Advancement, Joining/Re-joining at any part of the year shall pay the full annual subscription together with the admission fees for Advancement, Joining/Re-joining as the case may be. Honorary Members are not liable to pay any fees.

The treasurer will divide the Annual fees of Rs.400/- into Rs.250/- to General Fund, Rs.100/- to Stewards Fund and Rs.50/- to Benevolent Fund.

10. PERMANENT AND AUDIT COMMITTEES

There shall be a Standing Committee composed of the Master, Immediate Past Master, Present Wardens, Treasurer, Secretary, Director of Ceremonies and two Brethren elected at the Installation Meeting. There shall also be an Audit Committee of two brethren, whom are not members of the standing committee. The duties of the Standing Committee shall be to consider the applications of Candidates/Mark Master Masons for Advancement and Joining or Re-joining, check all the properties of the Lodge and report on the matters leading to the improvement of the Lodge. The Audit Committee shall verify and audit the Annual Statement of Accounts of the Lodge and shall certify the correctness thereof before being circulated to all the members prior to the Installation Meeting.

There shall be a *Permanent Committee* composed of the Master, Immediate Past Master, Past Masters in and of the Lodge, Present Wardens, Treasurer, Secretary, Director of Ceremonies and two Brethren elected at the Installation Meeting. The Permanent Committee will meet on the first Thursday of January, April, July and October or on such days and at such time as may be fixed by the Master. The duties of the Permanent Committee shall be to consider the applications of Candidates /Mark Master Masons for Advancement and Joining or Re-joining, check the accounts and the properties of the Lodge and report on the matters leading to the improvement of the Lodge. There shall also be an *Audit Committee* composed of two Brethren elected at the Regular Election Meeting in October along with the Master, Treasurer and Secretary of the Lodge. The Audit Committee shall verify and audit the Annual Statement of Accounts of the Lodge and shall certify the correctness thereof before being circulated to all the members prior to the Installation Meeting.

The above *amendments* were regularly Proposed and Seconded in open Lodge at a Regular Meeting held on 13th September 2001. Passed at a Regular Meeting held on 10th January 2002 and confirmed at a Regular meeting held on 12th September 2002.
