7(b) The treasurer shall keep accounts of the General Fund, Benevolent fund and the Refreshment Fund of Lodge. He shall allocate unit of monthly subscription of Resident Members Rs.30;Rs.22/- to G.F., Rs.7/- to HF & Rs.1/- to BF, Out of monthly subscription of non-resident members of Rs.23, Rs.22/- towards GF and Rs.1/- towards BF.

9(a) Fees :

Fee for initiation, for passing and raising with application Rs.1200/-

- 9(b) i) Fees for joining from another Constitution - Rs.1200/-.
ii) Fees for joining from our own Constitution - Rs.950/-.

(c) Fee for rejoining - Rs.100/- payable with application.

10) Subscription :

- a) Resident members Rs.30/- P.M.
b) Non-resident members Rs.23/-P.M.
c) In circumstances of emergency, Worshipful Master may afford relief upto Rs.25/-.

The Treasurer shall keep accounts of the General Fund, Benevolent Fund and the Refreshment Fund of the Lodge. He shall allocate unit of monthly subscription of Resident Members Rs.75/-; Rs.35/- to GF, Rs.20/- to RF & Rs.20/- to BF. Out of monthly subscription of non-resident members of Rs.55/-; Rs.35/- towards GF and Rs.20/- towards BF.

Fees :

Fee for initiation for passing and raising payable with application Rs.2500/-.

Fees for joining from another Constitution - Rs.2,500/-.

Fees for joining from own constitution Rs.1500/-.

Fees for rejoining - Rs.1000/- payable with application + Arrears due as on date of cessation of membership.

Subscription :

- Resident members Rs.75/- P.M.
Non-resident members Rs.55/- P.M.
In circumstances of emergency Worshipful master may afford relief upto Rs.500/-.

Annual subscription of Rs.900/- apart from RGL and GLI dues at actuals as per and shall also be payable by 31st March of every calendar year. If the payment is not made by any member by the following 30th Sept. of the calendar year, the treasurer shall give a month's notice by letter sent under Registered Post to the last known address. If the payment is not received by the 30th October of the calendar year the rule of cessation of membership as provided under the bye-law shall apply.
