
## **SUB:AMENDMENT TO BYE-LAWS OF LODGE G.K.DEVARAJULU NO.221**




Existing By-Laws	Proposed amendments to By-Laws
By-Law No.35, 36, 37.	By Law No.35,36,37.
35. A Regular member shall pay a Sum of Rs.750/- per year of which Rs.450/- will be towards subscription And Rs.300/-towards stewards charges. This sum of Rs.750/- is payable before The end of 31 <sup>st</sup> March every year. A Regular member shall also pay along with the subscription & Stewards charges a sum equivalent to the RGL & GLI Dues payable per member per year.	35. Subscription and Fees. The annual subscription of the members shall be Rs.1,000/-made up of Rs.500/-towards the General Fund and Rs.500/-towards the Stewards Fund payable on or before 31 <sup>st</sup> March every year, in addition each member shall pay RGL and GLI dues as application from time to time.
36. The Initiation fee shall be Rs.2000/- and the joining fee shall be Rs.1000/- Besides a sum equivalent to RGL & GLI Dues payable per member per year is to be paid along with the annual subscription and shall be payable in advance.	36. Following shall be the fees payable in advance: Initiation Rs.4,000/- Joining Rs.3,000/- Inclusive of all annual subscription, RGL and GLI dues, Apron, Ritual book for the first year and as per clause 35 for subsequent years.
37. The Rejoining fee shall be Rs.1000/- along with a sum equivalent to RGL & GLI Dues payable per member per year and shall be payable in advance along with the annual subscription.	37. Following shall be the fees payable in advance: Re-joining Rs.3,000/- Inclusive of all annual subscription, RGL and GLI dues, Apron, Ritual book for the first year and as per clause 35 for subsequent years.






