The Annual Subscription shall be Rs.750/- This apart shall each member shall also pay the per capita and other dues if any payable to the G.L.I and R.G.L.I on his account b) Out of the subscription amount such amount as decided by the Lodge from time to time shall be set apart towards dinner and refreshment expenses.
