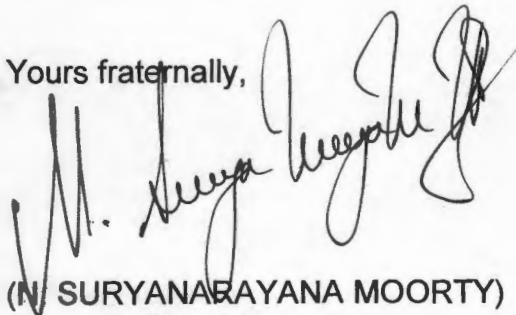

Existing By-Laws

By-Law No. 22A
