		1.	Membership Members shall comprise of only two classes, viz. Subscribing Companions and Honorary Companions.
1.	Regular Convocations: The Regular Convocations of the Chapter shall be held at Freemasons' Hall, Mangalore - 575 015, on the First Saturday in February, May, August and November at 6:30 P.M. or at such time as the Principals may fix from time to time.	2.	Regular Convocations (NO CHANGE) The Regular Convocations of the Chapter shall be held at Freemasons' Hall, Mangalore - 575 015, on the First Saturday in February, May, August and November at 6:30 P.M. or at such time as the Principals may fix from time to time.
2.	Election of Officers: The Officers shall be elected annually by ballot in the month of August and shall be installed and invested at the next succeeding Convocation of the Chapter. The Janitor shall be elected by a show of hands. Companions may empower the Principals elect to appoint the rest of the Officers under R.A. Regulations 52.	3.	Election and Installation Convocations The Principals shall be elected annually by ballot at the Regular Election Convocation of the Chapter in August and shall be installed at the next Regular Installation Convocation of the Chapter in November. The Treasurer shall be elected by Ballot and Janitor shall be elected by show of hands respectively each year at the Regular Election Convocation of the Chapter in August and invested at the Regular Installation Convocation in November. Companions may empower the Principals elect to appoint the rest of the Officers under R.A. Regulations 52.
3.	Emergent Convocations: A Chapter of Emergency may be called on summons of the First Principal or the other two Principals with the concurrence of the First Principal, if present. Seven clear days' notice shall be given of every Chapter of Emergency. Permanent Committee: There shall be a Permanent Committee composed of the First Principal as President, the Second and Third Principals, Scribes, Treasurer, Principal Sojourner and all Past First Principals in the Chapter. The duties of the Permanent Committee shall be to consider the applications of candidates/companions for exaltation and joining, check the accounts of the Chapter and present annually at installation Convocations a report on the working of the Chapter for the previous year and to consider all other matters concerning the Chapter. The Treasurer shall place such audited statement of accounts with the Balance sheet before the Audit Committee for approval and the same shall be circulated to the members at the Annual Installation convocation.</p>
	<p>8. Treasurer and Accounts: The Treasurer, with the assistance of the Scribe 'E', shall receive all moneys and settle accounts of the Chapter. The Principals if they so desire may entrust the properties mentioned above to Scribe "E" on their behalf for proper care and custody.




