





(a) If any Companion is in arrears of Subscription, to his Chapter for a year, the Scribe shall advise him of the amount due from him by Registered Post and if the full amount be not paid, within 30 days from the date, he shall be excluded in accordance with Reg. 75 of R.A.Regulations.

If the subscription of the Companion to his Chapter remains unpaid for two full years, at the expiry of the period, he shall cease to be a member of the Chapter and the fact shall be reported to the Chapter at its next Regular Convocation and recorded in the minutes.

In either case, he can become a member again, only by payment of the arrears, followed by regular proposition and ballot according to Reg.70 of the R.A.Regulations.

(b) The Jamitor, if he is a Serving Companion, shall be paid such remuneration as may be decided by the Chapter from time to time for each Convocation of the Chapter. He shall be exempted from payment of subscription.

If any Companion is in arrears of Subscription, to his Chapter for a year, the Scribe shall advise him of the amount due from him by Registered Post, and if the full amount be not paid, within 30 days from the date, he shall be excluded in accordance with Reg.75 of R.A.Regulations.

If the subscription of the Companion to his Chapter remains unpaid for two full years, at the expiry of the period, he shall cease to be a member of the Chapter and the fact shall be reported to the Chapter at its next Regular Convocation and recorded in the minutes.




