<b>Existing</b>  1 (a) The Lodge shall have 4 meetings in a year and meets on 2 <sup>nd</sup> Friday of Feb, June, Aug and December. Two meetings in Goshamahal Masonic Temple, one at St. John's Masonic Temple at Secunderabad, Fourth one shall be at any other place including twin cities to be decided by the Lodge at such an hour as the W.M may direct.  2 (a) The annual subscription shall be for 1. Resident Member - Rs 500.00 2. Non-Resident Member - Rs 300.00 In addition to the above all the members shall have to pay the GLI & RGL dues.	<b>Proposed Amendment</b>  The Lodge shall have 4 meetings in a year and meets on 2 <sup>nd</sup> Friday of March, June, September & December. All the 4 meetings will be held at Goshamahal Baradari Masonic Temple, Hyderabad.  The subscription payable by a Joining Member shall be only for the proportionate subscription from the date of joining to the remaining period of the year. In addition to the above the Joining Members shall pay for the proportionate GLI & RGL Fees or the Quarter / Half Year / Year as the case of the individual Joining Brother may be.

The above amendments were regularly Proposed and Seconded in open Lodge at a regular Meeting held on 13<sup>th</sup> AUG, 2004 Passed at a regular Meeting held on 17<sup>th</sup> FEB, 2005 and confirmed at a regular Meeting held on 10<sup>th</sup> JUNE, 2005
