
## SUB:AMENDMENT TO BYE-LAWS OF LODGE WESTERN STAR NO.363





3	The regular meetings of the Lodge shall be held at Dr. T.D.Nair Memorial Freemasons' hall, Talap, Kannur – 670 004, on the THIRD SUNDAY in the month of April, June, August, October, December and February at such hour as the Ruling Master decides from time to time.	The regular meetings of the Lodge shall be held at Dr. T.D.Nair Memorial Freemason's hall, Talap, Kannur – 670 004, on the THIRD SUNDAY in the months from February to October at such hour as the Ruling Master decides from time to time. The Lodge shall not have regular meetings in the month of November, December and January.
6	The annual subscription for the Resident and Non resident member shall be Rs.700.00 and shall be due and payable on the first of April every year. The actual annual/half yearly dues as demanded from time to time by the Grand lodge of India and the Regional Grand Lodge of Southern India shall also be payable.	The annual subscription for the Resident and Non resident member shall be Rs.1000.00 and shall be due and payable on the first of February every year. The actual annual/half yearly dues as demanded from time to time by the Grand lodge of India and the Regional Grand Lodge of Southern India shall also be payable.
7	The following shall be the fees payable in advance: Initiation Rs. 2000.00 Joining Rs. 1000.00 Re Joining Rs. 1000.00  The registration fees to the Grand Lodge of India and the Regional Grand Lodge of Southern India as applicable and prescribed and demanded from time to time. 


