PROPOSED AMENDMENTS TO / REVISED BY LAWS

(To be Submitted in Triplicate)

Existing By-Laws	Amended By-Laws
By-Law No. <u>3 (1)</u> Every Resident Member shall pay Rs. 500 per annum and every Non-Resident Member shall pay Rs. 300 per annum in advance as subscription to the Treasurer on or before the 30th April each year apart from the dues and fees payable for such member to the Grand Lodge of India and the Regional Grand Lodge of Southern India for the year, as applicable from time to time. Every Resident Member and Non-Resident Member who is otherwise qualified may opt to become a Life-Member with the payment of a one-time all-inclusive Life-Membership fee of Rs. 10,000.	By-Law No. <u>3 (1)</u> Every Resident Member shall pay Rs. 1,050 per annum and every Non-Resident Member shall pay Rs. 600 per annum in advance as subscription to the Treasurer on or before the 30th April each year apart from the dues and fees payable for such member to the Grand Lodge of India and the Regional Grand Lodge of Southern India for the year, as applicable from time to time. Every Resident Member and every Non-Resident Member who is otherwise qualified may opt to become a Life Member with the payment of a one-time all-inclusive Life-Membership fee of Rs. 10,000. Rs. 500 from out of the subscription received from Resident Members and Rs. 300 from out of the subscription received from Non-Resident Members shall be transferred to the Stewards Fund of the Lodge. A sum of Rs. 50 from out of the subscription received for the year from Resident Members shall be paid as Installation & Contribution to the W. Master who is Installed in that year towards reimbursement of his Installation expenses.
By-Law No. 7 (199) Every Resident Member shall pay Rs. 50 in addition to his subscription as contribution towards Annual Installation expenses incurred by the W. Master and every Non-Resident Member who attends the Installation Meeting shall also pay Rs. 50 in addition to his subscription. By-Law No. 7 (199)	By-Law No. 7 (199) Every Non-Resident member who attends the Installation Meeting shall pay Rs. 50 as Installation Contribution in addition to his subscription which shall be paid to the W.
