Honorary Members shall not be liable for any fees payable to the Lodge</p> <p>The above subscriptions do not include the amounts payable to Grand Lodge of India and Regional Grand Lodge of Southern India</p> <p>Any member allowing his annual subscription to remain unpaid either wholly or in part for a period of 6 months from the 1<sup>st</sup> March shall receive intimation of the same from the Secretary by 1<sup>st</sup> Week of September by Registered Post to his latest known Address and if the dues are not cleared on or before the last day of October, he shall be liable for exclusion at the Meeting to be held in November, in accordance with Rule 156 of the Book of Constitutions.</p>	<p>The Maximum Subscription and other dues payable shall be as follows:  Subscription:  Resident Members Rs. 3000 per year  Non-Resident Member Rs. 1500 per year  Other Dues:  Stewards Fund Rs. 1000 per year  Almoners Fund Rs. 300 per year</p> <p>The Subscription and other dues for the year, subject to the above maximum limit shall be determined by the Permanent Committee at the Permanent Committee meeting prior to the Installation meeting based on the accounts presented by the Treasurer and will come into immediate effect and be intimated to the members in the summons for the next Regular Meeting.
