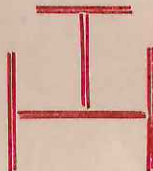

BY-LAWS
OF
CHAPTER EUREKA
No. 6 GCI

1. Regular Convocation

The Regular Convocation of the Chapter shall be held at Freemansons' Hall, Bangalore, on the Third Friday in April, June, October and December and on the Fourth Friday in February and August, at such hour as the three Principals may appoint.

2. Election of Officers

The Three Principals and other Officers of the Chapter shall be elected annually at the Regular Convocation in

February. The mode of election shall be by ballot, for the Office of First Principal in the first instance and the Officers in succession ; provided that by a resolution of the Chapter duly proposed and carried in that Election Meeting, save in the case of the Treasurer and Janitor, the Three Principals may be empowered to appoint the other Officers of the Chapter, for that Year, instead of the same being elected by ballot. The Officers shall be invested and inducted at the next Regular Convocation. The Janitor may be elected by a show of hands.

4. Permanent Committee

The Permanent Committee shall consist of the Three Principals, Past First Principals, Scribe, E., Treasurer and two Companions elected on the Installation Day. The First Principal, shall be the Chairman of the Committee

5. Audit Committee

A Committee shall be appointed annually at the February Convocation to audit the Treasurer's accounts and

report thereon at the installation Convocation.

6 Alteration of By-Laws

No resolution or alteration, in or addition to these By-Laws shall be introduced or discussed in the Chapter until notice of the same shall have been given in writing, in open Chapter at a Regular Convocation, and afterwards circulated with the summons for the next ensuing Convocation unless introduced by the report of the Committee.

All matters not specially provided for by the Royal Arch Regulations or these By-Laws, shall be decided according to Book of Constitutions (Craft)
