### FEES and SUBSCRIPTIONS:

No.9: Fees shall be paid in advance for all the Three Degrees: Rs.1500.00

No.9: Fees shall be paid in advance for all Three Degrees: Rs.2000.00

Joining from any Lodge under any Constitution: Rs.1500.00

Joining from any Lodge under any Constitution: Rs.2000.00

Subscription from Resident Member: (per month): Rs. 150.00

Subscription from Resident Members: (per month) Rs. 200.00

Subscription from Non-Resident Member(per month): Rs. 50.00

Subscription from Non-Resident /Resident Members in absentee list: (per month): Rs. 75.00

### GENERAL FUND:

#### No. 13.

Monthly subscription paid the Lodge as well as other monies not otherwise specifically allocated shall be credited to the General Fund. Payment from the Fund, except for routine purpose can be made only by resolution of the Lodge. Out of the monthly subscription of Rs.150.00 paid by every Resident Member, a sum of Rs.80.00 shall however be credited to the Steward's Fund.

#### No.13:

Monthly subscription paid by the Members as well as other monies not otherwise specifically allocated shall be credited to the General Fund. Payment from the Fund except for routine purposes can be made only by resolution of the Lodge. Out of the monthly subscription of Rs.200.00 paid by every Resident Member, a sum of Rs.90.00 shall however be credited to the Steward's Fund and Rs.50.00 shall be credited to the Benevolent Fund.

Out of the monthly subscription of Rs.75.00 paid by Non-Resident and Resident Absentee Members, a sum of Rs. 25.00 shall be credited to the Benevolent Fund. Other than this, the Lodge can transfer funds to the Benevolent Fund / Steward's Fund by resolution of the Lodge.




Rs.50.00 from the monthly subscription of Resident Members and Rs.25.00 from the monthly subscription of Non-Resident and Resident Members in absentee list.






