The Treasurer shall be elected annually by ballot at the Regular Election Meeting in the month of October (vide Rule 92 A of the B. of C.) c. The Tyler shall be elected annually by ballot or show of hands at the Regular Election Meeting in the month of October (vide Rule 93 of the B. of C.)
