



<p><u>Election</u> 4. The three Principals, two Scribes, Treasurer, Principal Sojourner and two Assistant Sojourners shall be elected by the ballot at the regular Convocation in September; while the Janitor, subject to the provisions of Regulation 52, para 5, Royal Arch Regulations, shall be elected by show of hands. In addition to the above Officers, a Director of Ceremonies, an Organist, an Assistant Scribe E, and Stewards maybe elected or appointed, as the case may be. The Installation of Principals Elect and investiture of Officers shall take place at the regular Convocation in December. Under Rule 52, para 3, Royal Arch Regulations, the Chapter may, on the day of election, by a resolution, give the authority to the Principals Elect to appoint the rest of the Officers</p>	<p><u>Election</u> 4. The three Principals and Treasurer shall be elected by Ballot at the Regular (Election) Convocation (in the month of September), subject to the provisions of Regulation 52 of the Royal Arch Regulations and the Janitor shall be elected by show of hands. In addition, the Three Principals elected are empowered to appoint all other Officers specified in Rule 52, paras 1 & 2. The Officers of the Chapter shall consist of the Three Principals (Elected), Scribe E, Scribe N, Treasurer (Elected), Director of Ceremonies, Principal Sojourner, 1st Assistant Sojourner, 2nd Assistant Sojourner, Assistant Director of Ceremonies, Assistant Scribe E, Organist, Stewards and Janitor (Chosen). The Installation of Principals Elect and investiture of Officers shall take place at the regular Convocation in December.</p>
<p><u>Admission</u> 5. The admission of the candidates for Exaltation and Joining shall be regulated by the provisions of Regulations 69 to 72, Royal Arch Regulations.</p>	<p><u>Admission</u> 5. The admission of the candidates for Exaltation and Joining/Re-joining shall be regulated by the provisions of Regulations 69 to 72, Royal Arch Regulations. A period of at least one year shall elapse before any rejected candidate can be proposed again.</p>



Existing By-Laws

Fees & Subscriptions

6. The following are the fees and subscriptions of the Chapter, strictly payable in advance:

Exaltation	Rs.1,000
Joining & Rejoining	Rs. 500
Subscription per quarter:	
a. Resident Members	Rs. 150
b. Non-Resident/ Absent Members	Rs 75

Out of the quarterly subscription of Rs.150 paid by the Resident Member, a sum of Rs.70 shall be credited to the "Stewards Fund" to cover the cost of the Dinner and Rs.50 towards General Fund. 20% of any subscription amount received shall be credited to the Charity Account.

Resident Absent Members (RA) who are invalid, infirm, disabled and/or in financial distress and unable to attend the Convocations of the Chapter, shall on application to the Chapter be charged a quarterly subscription of Rs.50, instead of the prescribed fee under By-Law No. 6 of the Chapter.

They shall, however, be charged the prescribed fee of Resident Members for the month/months in which they attend the Convocation of the Chapter.

In addition to the subscription, the membership fees levied by the Supreme Grand Chapter of India and the Regional Grand Chapter of Southern India shall be payable by all members in advance during the month of January of every year..



If any member be in arrears with his subscription to the Chapter for four quarters, the Scribe E shall advise him of the amount due by him by registered post, and if the FULL amount be not paid within thirty days from the date thereof, he shall be excluded in accordance with Regulation 75, Royal Arch Regulations.</p>	<p>12. If any member be in arrears with his subscription to the Chapter for one year, the Scribe E shall advise him of the amount due by him by registered post, and if the FULL amount be not paid within thirty days from the date thereof, he may be excluded in accordance with Rule 156 of BoC (Craft). If his subscription remains unpaid for two full years, he shall cease to be a member of the Chapter as per Regulation 75 of Royal Arch Regulations.</p>
<p><u>The Treasurer</u> 16. The Treasurer will collect all moneys due to the Chapter, make all necessary disbursements when duly passed for payment by the First Principal in charge of the Chapter, and is responsible for the safe custody of the Chapter funds. He will pay all sums exceeding Rs.100 by cheque and pay all moneys received by him into the Bank soon thereafter retaining Rs.300 only for emergencies. He will balance the Chapter Accounts and submit them for audit to the Audit Committee. In the absence of the Treasurer, moneys will be collected by the Scribe E who will pay over the same to the Treasurer soon thereafter.</p>	<p><u>The Treasurer</u> 16. The Treasurer will collect all moneys due to the Chapter, make all necessary disbursements when duly passed for payment by the First Principal in charge of the Chapter, and is responsible for the safe custody of the Chapter funds. He will pay all sums exceeding Rs.1,000 by cheque and pay all moneys received by him into the Bank soon thereafter retaining Rs.1,000 only for emergencies. He will balance the Chapter Accounts and submit them for audit to the Audit Committee. In the absence of the Treasurer, moneys will be collected by the Scribe E who will pay over the same to the Treasurer soon thereafter.</p>



Committees Permanent Committee: 18. There will be a Permanent Committee of the Chapter consisting of the Three Principals, Scribes E & N, Treasurer, Principal Sojourner and all the past First Principals who are members of this Chapter. The First Principal or in his absence the senior past Principal present shall preside. The Three Principals may call the Permanent Committee meeting whenever necessary to do so to discuss any matter they deem fit. The Committee will consider all matters referred to it by the Chapter and the Accounts before the Convocation in December. Three to form a quorum.	Committees Permanent Committee: 18. There will be a Permanent Committee of the Chapter consisting of the Three Principals, Scribes E & N, Treasurer, D of C, Principal Sojourner, First Asst. Sojourner, Second Asst. Sojourner, Asst. Scribe E, Asst. D of C and all the past First Principals who are members of this Chapter. The First Principal or in his absence the senior past Principal present shall preside. The Three Principals may call the Permanent Committee meeting whenever necessary to do so to discuss any matter they deem fit. Funds 21. (b). Accounts 22. Accounts should be opened in the name of the Chapter in Bank(s) approved by the Chapter.	Bank Accounts 22. Bank Accounts should be opened in the name of the Chapter in Nationalised Bank(s) only approved by the Chapter.


